5. The Promotion will be judged by a panel of judges selected by the Promoter. Judging will commence on 22nd June 2007 at the promoters premises. Winners will be notified by email using contact details provided in their entry on the 7th July 2007. The names of and the winning entry, the second and third best entries will also be published in the July edition of the Golf Australia E Newsletter sent on 7th July 2007. This is a game of skill, chance plays no part in determining the winner. Each entry will be individually judged based on literary and creative merit. The judges' decision in relation to all aspects of the Promotion is final and binding on all who enter. No correspondence will be entered into.
