



## Golf Australia October E News Competition

### Terms and Conditions

1. Information on how to enter and prizes form part of these conditions of entry.
2. Entry is open to residents of Australia only. Employees of the promoter and their immediate families and agencies associated with this promotion are ineligible to enter.
3. Promotion commences Thursday October 4, 2007 at 4:00pm AEST and closes last email received Wednesday October 31, 2007 at 11:59pm AEST.
4. To enter tell us in 50 words or less what your biggest golfing dummy spit is. Also include your name, address and daytime telephone contact details. Send your completed entry by email to: [eclub@golfaustralia.org.au](mailto:eclub@golfaustralia.org.au). Only one entry per person permitted. Incomplete entries will be deemed invalid and will not be included in the judging.
5. The Promotion will be judged by a panel of judges selected by the Promoter. Judging will commence on Thursday November 1, 2007 at the promoters premises. Winners will be notified by email using contact details provided in their entry on November 1, 2007. The names of and the winning entry, the second and third best entries will also be published in the July edition of the Golf Australia E Newsletter sent on November 1, 2007. This is a game of skill, chance plays no part in determining the winner. Each entry will be individually judged based on literary and creative merit. The judges' decision in relation to all aspects of the Promotion is final and binding on all who enter. No correspondence will be entered into.
6. There is one prize to be won. The best entry as determined by the judges will win the major prize valued at \$40 (retail price excluding GST). This prize is box of twelve (12) Srixon Z-URS golf balls.
