

## **2007 MFS AUSTRALIAN OPEN TICKET TERMS AND CONDITIONS**

1. Tickets may not be resold at a premium or used for advertising, promotion or other commercial purposes without the prior written consent of IMG (the "Event Organiser"). If this ticket has been resold or used in contravention of the condition, the bearer of the ticket may be denied admission or may be asked to leave the venue.
2. Mobile phones must be on silent whilst in the competition areas of the venue. You agree to comply with all notices at the venue and all directions from the Event Organiser, including directions from course marshals in relation to silence whilst players hit, roped areas and other matters. You may be removed from the venue if you do not comply any direction from the Event Organiser or its representatives.
3. Tickets are not refundable or subject to exchange unless required by law. If a days play is cancelled after it has started (for example, because of bad weather), you cannot exchange your ticket and you cannot obtain a refund. If the description of, or participants in, an event change, you cannot exchange your ticket and you cannot obtain a refund. The Event Organiser is not liable to you for any claims, damages, compensation, losses or expenses as a result of the event or days of the event being cancelled, postponed or changed.
4. You understand that the layout of the venue may be unfamiliar to you, so you must take care at all times. You acknowledge that you are responsible for your own safety and for the safety of any children accompanying you. Ticket holders enter the venue at their own risk. The Event Organiser advises that due to the uneven and, in parts, steep terrain of this course it may at times be difficult for spectators to move around freely and easily, as a result of which, it may not be suitable for those spectators who suffer from certain medical conditions. You are advised to wear suitable footwear and to be careful in moving around the golf course. To the extent permitted by law you release the Event Organiser (including its directors, officers, employees, consultants, contractors, agents and volunteers) from any liability for any damage, loss, liability or injury you may suffer in relation to your attendance at the event, howsoever caused including without limitation being struck by a golf ball or due to any negligence or other act or omission of the Event Organiser or its representatives, agents, contractors and/or volunteers. You agree to compensate the Event Organiser for any damage, loss, liability or injury the Event Organiser may suffer as a result of your willful, reckless or negligent acts or omissions at the event.
5. You are responsible for your own property whilst at the venue.
6. The Event Organiser may refuse you entry into, or remove you from, a venue if you do not obey these terms and conditions, you interfere with the enjoyment, comfort or safety of other persons at the event, you have a lost, stolen, counterfeit, damaged or unreadable ticket or you have acquired your ticket from an unauthorised source, or the Event Organiser reasonably suspect you of any of the above.
7. No camera, video or audio equipments is allowed on course.
8. A separate parking ticket is required for access to official car parks.
9. These ticket conditions may be supplemented by additional conditions displayed at the venue.
