



## December E News Competition

### Terms and Conditions

1. Information on how to enter and prizes form part of these conditions of entry.

Incomplete entries will be deemed invalid and will not be included in the judging.
5. The Promotion will be judged by a panel of judges selected by the Promoter. Judging will commence on Thursday **January 1** at the promoters premises. Winners will be notified by email using contact details provided in their entry. The names of and the winning entry, the second and third best entries will also be published in the December edition of the Golf Australia E Newsletter sent on Thursday **December 1, 2008**. This is a game of skill, chance plays no part in determining the winner. Each entry will be individually judged based on literary and creative merit. The judges' decision in relation to all aspects of the Promotion is final and binding on all who enter. No correspondence will be entered into.
