WOMEN'S CORONATION MEDAL TOURNAMENT CONDITIONS

These are to be read in conjunction with the Golf NSW Standard Conditions.

Should a conflict occur between conditions, then the conditions outlined on the entry form take precedence.

1. Tournament Procedure

- 1.1** The event will be played in accordance with the Rules of Golf as approved by the R&A Rules Limited, the Golf NSW Standard Conditions for State Events and the Local Rules as approved by the Championship Committee.
- 1.2** The Coronation Medal is an 18-hole nett teams event. To be won by the best net aggregate of four (4) players within the prescribed handicap limits entering from the same club.
- 1.3** The event will be played on two courses - the club may nominate two players for its Team for each course. Team members may only be nominated from one club. Provided a player's handicap falls within the prescribed limits at the time of entry a player whose handicap changes before the day of play is eligible to play in the team but must play off her current handicap on the day of the event.
- 1.4** In the event of a Team member being unable to play, the club may nominate another player within the prescribed handicap limit **up to one week prior to the event (except in the case of an emergency where later entries will be accepted).**
- 1.5** The course of the club winning the Coronation Medal will be the No. 1 Course and the course of the club finishing in second place will be the No. 2 Course for the event in the following year. In the event of joint winners, both courses will be used and if more than two, the two courses will be decided by ballot. The following exceptions apply: (a) if a club is situated outside the metropolitan area, or (b) the club is a 9 hole course. If a club is not eligible to host the Coronation Medal in the following year, the third placegetter will be approached and so on.
- 1.6 Ties:** In the event of a tie in the Coronation Medal, such Clubs shall be declared Joint Winners. Ties in second and third place are to be determined by the Australian Method of countback, over the last 9, 6, 3 etc. using all four players scores i.e. aggregate countback. All other ties will be determined by the Australian Method of countback
- 1.7 Presentation of Trophies:** Will be at conclusion of play at each course for the singles event and the Coronation Medal presentation to the winning club will be held at a date and venue to be determined by the Match Committee and the winning club.
- 1.8 Prizes:** 18-hole nett teams event. To be won by the best net aggregate of four (4) players within the prescribed handicap limits entering from the same club.
18-hole scratch and net singles events in conjunction at both courses

2. Championship Play Committee

- 2.1** The Championship Play Committee will comprise the Chair of the Golf NSW Women's Match Committee, Golf NSW General Manager - Golf, and Golf NSW Chair Rules Committee, or their appointees.
- 2.2** In the absence of a full Championship Play Committee, such members as may be present at the time may give a decision, and any decision so given will be deemed to be a decision of the full Championship Play Committee.
- 2.3** The Championship Play Committee will have the sole management and control of the Championship, with full power at any time to alter or vary any of the conditions.
- 2.4** The Championship Play Committee's decision on matters affecting the Championship will be final.

3. Rules of Play

The Rules of Golf, as adopted by R&A Rules Limited, will apply, together with Golf NSW Hard Card (see condition 15), and any additional Local Rules as drawn up by the Championship Play Committee

4. Entries

- 4.1** Eligible players are female amateurs whose Australian Handicap (or overseas equivalent) does not exceed 22
- 4.2** The entry fee per TEAM is \$60 (including GST)
- 4.3** Entries must be made via the Golf NSW website, entry form issued by Golf NSW, or a facsimile copy thereof. Entry by email is acceptable provided it is a scanned image of the official entry form.
- 4.4** Any player who has entered the Coronation Medal on a correct handicap and whose handicap increases or decreases beyond the handicap limit for the event **after the close of entries** will be permitted to play in the event originally entered on their current handicap. Should their handicap change **prior to close of entries** they must immediately advise Golf NSW.
- 4.6** The decision of the Championship Play Committee as to acceptance or refusal of any entry will be final.
- 4.7** Entrants must conform in all respects to the Rules of Amateur Status, as adopted by R&A Rules Limited.
- 4.8** Fully completed Entry Forms must be received by Golf NSW prior to 5.00 pm Monday 22 August 2011. IT IS THE SOLE RESPONSIBILITY OF THE ENTRANT TO ENSURE THAT THE ENTRY IS RECEIVED PRIOR TO THE CLOSING TIME FOR ENTRIES.
- 4.9** Postal or faxed entries must be accompanied by a copy of the entrant's current handicap record for the previous six months, officially endorsed by entrant's Club, unless the entrant has provided his GOLF Link number on the Entry Form
- 4.10** In the event of entrants exceeding the number of places available in the Tournament, precedence will be given in order of receipt of entry. Unsuccessful entrants shall be informed without delay and given the opportunity to compete if withdrawals subsequently occur. Entrance fees will be refunded to entrants balloted out, who do not subsequently compete.
- 4.11** In the event of an entrant being suspended by an affiliated club, a club affiliated with a District Golf Association, a District Golf Association on a golf related matter the entrant shall not be eligible to enter the Championship, even if they nominate another club as their home club for handicap purposes.
- 4.12** Late entries may be accepted at the discretion of the Championship Play Committee and will incur a \$20 late fee.
- 4.13** Acceptable payment methods are only as follows – credit card (Visa or MasterCard only), cheque (personal or bank), money order, cash (please note that Golf NSW will NOT accept responsibility for cash sent that is not received). Cheques or money orders are to be made payable to Golf NSW.

4.14 Only entry forms accompanied by credit card payment will be accepted by facsimile or email. Entry forms accompanied by other acceptable payment methods must be submitted by post or in person. Entries will not be accepted by telephone. Entry forms will not be accepted unless they are fully completed.

4.15 Entrance Fees will only be refunded in the case of a withdrawal being advised before the closing time for entries, except for those entrants who fail to secure a place, or after the close of entries for medical reasons (a medical certificate must accompany a request for withdrawal on medical grounds). All refunds will incur a \$10 processing fee.

4.16 Entrants must abide by the dress regulations of the host club.

5.Exemptions

There are no exemptions for this tournament

6.Television and Media

All rights for televising live, television recordings or for any visual or electronic reproduction of the Championship are reserved only to Golf NSW and may only be made under licence.

7.Conforming Golf Balls, Conforming Driver Heads, and Time of Starting

The specimen conditions in the Rules of Golf are in effect as regards Conforming Golf Balls, Conforming Driver Heads, and Time of Starting.

8.Drug Testing and Alcohol

All competitors are subject to drug testing as outlined in the Golf NSW Code of Conduct. The Consumption of Alcohol condition as outlined in the Golf NSW Standard Conditions for State Events applies to this tournament.

9.Code of Conduct and Exclusion of Liability

All entrants are bound by Golf NSW' Code of Conduct ("the Code"). A copy of the Code is available at www.golfnsw.org. Any breach of the Code may be recorded on the Central Register of the Code ("the Register"). The Register may be accessed (and published from time to time) by any State Association or Golf Australia for the purposes of administering Competitions or state championships, events, competitions, practice sessions or major activities conducted or sanctioned by a State Association, or any State Association or Golf Australia codes of conduct and/or other related matters.

10. Motorised Transport

The Golf NSW Standard Condition is in effect. Participants must walk at all times during a stipulated round unless permission has been granted by the Match Committee. Applications for permission **MUST** be made at the time of entry.

11: Caddies

Caddies are not permitted

12: Distance Measuring Devices

The specimen Local Rule on page 140 of the Rules of Golf 2008-2011 permitting their use applies for all play during the tournament.

13: Mobile Phones

The Mobile Phone condition as outlined in the Golf NSW Standard Conditions for State Events applies to this tournament

14. Practice

To be arranged with host club Professional Shops.

15. Registration

Competitors are to register 30 minutes before their starting time. Failure to comply may result in disqualification from the tournament

16. Pace of Play

Rule 6-7 will be strictly enforced. See the Golf NSW Hard Card for Pace of Play conditions.

17. Database of Competitors' Details

The personal data contained in this entry is permanently retained by Golf NSW. This data may be utilised by Golf NSW or its sponsors for the distribution of correspondence, in both electronic and hard copy means. From time to time players may be sent entry forms, event literature, the Golf NSW e-newsletter, or marketing material by the sponsor(s) of Golf NSW events, or information about events conducted by Golf NSW-approved bodies. Upon receipt by Golf NSW of a written request, a player may either have access to their details, or have their details deleted from the database.

18. Golf NSW Hard Card

The Golf NSW Hard Card will be in effect throughout the tournament.
