CONDITIONS

1. Format

- 1.1 The Bronze Foursomes will be played over 18 Holes of Stroke Play.
- 1.2 The Nora Maskell Trophy is an 18 Hole Handicap Foursomes event.
- 1.3 In the event of a tie in the Bronze Foursomes, unless the Match Committee determines otherwise, players in such a tie will continue play over such holes as the Match Committee will decide, in a sudden-death, hole-by-hole playoff until the winner is determined. Ties for other placegetters will be decided by countback.
- 1.4 In the event of a tie for the Nora Maskell Trophy, winners will be decided by countback.

2. Handicaps

- 2.1 **Bronze Foursomes:** A player entering on the handicap limit of 28 who exceeds that handicap before the first day of play may remain in the event playing on the handicap limit. A player entering on the handicap limit of 19 who reduces her handicap before the first day of play may apply to Golf SA or its representative for permission to continue in the entered event on her reduced handicap in the Net event only. The Gross event cannot be won by a pair who do not meet the 19-28 handicap limit on the day of the event.
- 2.2 **Nora Maskell Trophy:** A player entering on the handicap limit of 39 who exceeds that handicap before the first day of play may remain in the event playing on the handicap limit. A player entering on the handicap limit of 29 who reduces her handicap before the first day of play may apply to Golf SA or its representative for permission to continue in the entered event on her reduced handicap in the Net event only. The Gross event cannot be won by a pair who does not meet the 29-39 handicap limit on the day of the event.
- 2.3 Competitors are requested to bring proof of handicap.

3. Match Committee

- 3.1 The Match Committee will comprise the Golf SA Match Committee.
- 3.2 In the absence of the full Match Committee, such members as may be present at the time, may give a decision, and any decision so given will be deemed to be a decision of the full Match Committee.
- 3.3 The Match Committee will have the sole management and control of the Trophy, with full power at any time to alter or vary any one of the Conditions.
- 3.4 The Match Committee's decision on matters affecting the Trophy will be final.
- 3.5 Any dispute or protest must be made to the Match Committee not later than 15 minutes after the conclusion of play on the day on which the disputed matter has arisen.
- 3.6 The Match Committee may, in the event of bad weather or for any other reason, alter the venue, time or day of play.

4. Rules of Play

- 4.1 The Rules of Golf, as adopted by R & A Rules Limited, will apply together with Local Rules of the venue Club.

5. Entries

- 5.1 Eligible players for the Bronze Foursomes are female amateurs whose Australian Handicap or overseas equivalent is between 19 - 28 strokes.
- 5.2 Eligible players for the Trophy are female amateurs whose Australian Handicap or overseas equivalent is between 29 - 39 strokes.
- 5.3 If through illness or another unavoidable cause one entrant has to withdraw after the closing date of entry, her partner

may substitute another player in her stead, with the approval of Golf SA and upon payment of a further entry fee of \$10.00 (inc GST). A player loses her entry fee if she does not play.

- 5.4 The Entrance Fee for the Trophy is \$50.00 per pair (including GST), and must be paid at the time of entry.
- 5.5 Entries must be made on the entry form issued by Golf SA, or a facsimile copy thereof. Entry by email is acceptable provided it is a scanned image of the official entry form. Entries by phone not accepted.
- 5.6 The decision of the Match Committee as to acceptance or refusal of any entry will be final.
- 5.7 Late entries may be accepted at the discretion of the Match Committee.
- 5.8 Fully completed Entry Forms must be received by Golf SA by 5:00pm on Thursday 21st July 2011. IT IS THE SOLE RESPONSIBILITY OF THE ENTRANT THEMSELVES TO ENSURE THAT THEIR ENTRY IS RECEIVED PRIOR TO THE CLOSING TIME FOR ENTRIES.

6. Conforming Golf Balls, Conforming Driver Heads, and Time of Starting

- 6.1 The specimen conditions in the Rules of Golf are in effect as regards Conforming Golf Balls, Conforming Driver Heads and Time of Starting.

7. Drug Testing

- 7.1 All competitors are subject to drug testing by the Australian Sports Anti-Doping Agency for banned substances as laid down in Golf Australia's Anti-Doping Policy. Any competitor infringing this policy, or refusing to take a test, will be disqualified and subject to any sanction(s) brought down by ASADA.

8. Mobile Phones

- 8.1 Mobile phones must be switched off when on the golf course and may only be used in an emergency.

9. Pace of Play

- 9.1 Rule 6-7 will be strictly enforced. Each group must maintain its position on the course with respect to the group preceding it. Any group with a clear hole in front of it will be considered to be out of position. Penalties will be issued to individuals in such groups who by their pace contribute to such delay. Warnings may not be issued prior to penalties.

10. Motorised Transport

- 10.1 Ride-on buggies will be permitted only on medical evidence from the player's Club and by permission of the venue Club. Application and approvals to be forwarded with entry form. Caddies are not permitted to use ride-on buggies.

11. Code of Conduct

- 11.1 All entrants assent to be bound by Golf SA's Code of Conduct. A copy of the Code is available at www.golfsa.com.au.

12. Measuring Devices

- 12.1 For all play, a player may obtain distance information using a device that measures distance only.

13. Draws

- 13.1 Competitors will be drawn in such manner as the Match Committee shall arrange. The Match Committee reserves the right to alter the draw without notice.
- 13.2 Tee times will be available on the Golf SA website www.golfsa.com.au from Thursday 28th July 2011.
