## 2012 MEMBERS' GOLF DAY HUNTINGDALE GOLF CLUB

### CONDITIONS

#### 1. Format

1.1 The event will be played over 18-holes single Stableford for men and women at Huntingdale Golf Club on Monday 2 April 2012 with a tee off time of 7.30am.

1.2 Overall prizes will be awarded as follows:

- 1<sup>st</sup> Place
- 2<sup>nd</sup> Place
- 3<sup>rd</sup> Place

Should a woman not win one of the above prizes and there are two or more women in the field, the leading woman will be awarded a prize.

1.3 In the event of a tie for a prize, the winner will be determined by count-back.

#### 2. Rules of Play

The Rules of Golf, as adopted by R&A Rules Limited, will apply, together with the Local Rules distributed at the event.

#### 3. Entries

3.1 Eligible players are men or women financial members of the Crown Lager Social Golf Club.

3.2 The Entrance Fee is \$120.00 (includes GST).

3.3 Entrants must conform in all respects to the Rules of Amateur Status as adopted by R&A Rules Limited.

3.4 Entries must be received by Golf Australia by 5.00pm Friday 16 March 2012.

3.5 Applications will be accepted on a first come first serve basis. In the event of entry applications exceeding number of places, the remaining players will be placed on a waiting list.

3.6 Acceptable payment methods are only as follows – credit card (Visa or MasterCard only), cheque (personal or bank), money order, cash (please note though that Golf Australia will NOT accept responsibility for cash sent that is not received). Cheques or money orders are to be made payable to *Golf Australia*.

3.7 Entrance Fees will only be refunded in the case of a withdrawal being advised before the closing time for entries; or to those players on the waiting list who do not gain a start.

3.8 GA has the right to cancel the event should sufficient entries not be received. Entrants will receive a full refund should the event be cancelled.

#### 4. Code of Conduct

All entrants are bound by Golf Australia's Code of Conduct ("the Code"). A copy of the Code is available at [www.golfaustralia.org.au](http://www.golfaustralia.org.au). Any breach of the Code may be recorded on the Central Register of the Code ("the Register"). The Register may be accessed (and published from time to time) by any State Association or Golf Australia for the purposes of administering Competitions or state championships, events, competitions, practice sessions or major activities conducted or sanctioned by a State Association, or any State Association or Golf Australia codes of conduct and/or other related matters.

#### 5. Registration

Competitors must register at least 15 minutes before their starting time at Huntingdale Golf Club on Monday 2 April 2012.

#### 6. Database of Competitors' Details

The personal data contained in this entry is permanently retained by Golf Australia. This data may be utilised by Golf Australia or its sponsors for the distribution of correspondence, in both electronic and hard copy means. From time to time, players may be sent entry forms, event literature, the Golf Australia e-newsletter, or marketing material by the sponsor(s) of Golf Australia events, or information about events conducted by Golf Australia-approved bodies. Upon receipt by Golf Australia of a written request, a player may either have access to their details, or have their details deleted from the database.
