THE LAKES CUP & THE LAKES BOWL

2013 Conditions of Play

ELIGIBILITY:

- The Lakes Cup & The Lakes Bowl is open to amateur golfers with an Australian Women's Handicap **not exceeding 22.4** at the time of entry.
- Any player who enters on a handicap within the prescribed limit at close of entry, and whose handicap increases beyond the limit, will be permitted to compete on the maximum handicap.

ENTRY:

- Entries must be made on the official entry form and entry fees must accompany the entry form.
- Late entries will be accepted at the discretion of the Captain and will play where the draw allows
- Cancellations after Wednesday, 12 noon, prior to the event, are non-refundable except upon the production of a medical certificate or after a written request at the discretion of the Committee.
- Substitute players will not be accepted.

THE DRAW:

- The round will be played as a seeded draw using playing handicaps (whole number).
- The draw will be available on the 'Guests' section of The Lakes website.

FORMAT – THE LAKES CUP: SCRATCH

- No 1 Course
- One round of stroke over 18 holes
- Best scratch score over 18 holes

FORMAT – THE LAKES BOWL: NETT

- Bowl played in conjunction with The Lakes Cup on No 1 Course
- One round of stroke over 18 holes
- Best nett score over 18 holes

TROPHIES:

- Players are limited to one trophy
- Scratch event takes precedence over handicap event.
- Order of prizes: 1st prize takes precedence over 2nd

TIES:

- Winner of **scratch event** - Joint winners
- Winner of **nett event** - Decided by countback
- Ties in subsequent positions Decided by countback

CADDIES AND CARTS:

- Players may have a caddie
- Motorised transport is permitted provided the player has a current medical certificate issued within the preceding 12 months. Copy must be attached to the entry form

MOBILE PHONES:

- As per Golf NSW standard conditions of play.

DISTANCE MEASURING DEVICE

- For all play at this course, a player may obtain distance information by using a device that measures distance only. If, during a stipulated round, a player uses a distance measuring device that is designed to gauge or measure other conditions that might affect his play (eg gradient, windspeed, temperature, etc), the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional function is used

The Committee shall have full power to alter or make any variations to the Conditions should it deem it desirable
