TOURNAMENT CONDITIONS AND INFORMATION

- 1 The Committee of the Royal Hobart Golf Club reserves the right to close the whole or any portion of the course for any period it may deem necessary, either before or during the tournament.
- 2 All events are open to Amateur members of recognised golf clubs, and who have a Golflink number.
- 3 Royal Hobart Golf Club reserves the right to make any alteration in the programme, and to refuse entry without assigning a reason.
- 4 The Rules of Golf and the Local Rules of Royal Hobart Golf Club shall be the rules of play throughout the Tournament.
- 5 All Handicaps will be controlled by the Committee of Royal Hobart Golf Club. The Committee reserves the right to make alterations in the handicap of any entrant before he/she commences play in any event, should it be deemed desirable.
- 7 All ties shall be decided by counting back, with the exception of Event No 3, which will be decided by a three hole play off and then, should scores still be tied the result will be decided by a sudden death.
- 8 Trophies – Events 2, 3 & 4 – player (s) are eligible to win only one trophy (nett or gross)
- 9 No refunds will be given after 7 days prior to the event.
- 10 **All entry fees must accompany entry form.**

DRESS CODE - as of November 2012

Each Member owes a duty to his/her fellow Members to maintain standards befitting Royal Hobart Golf Club. It is the responsibility of all Members to ensure that their guests conform to the regulations of the Club.

CLUBHOUSE

The Dress Code in all areas of the Clubhouse is smart casual attire. Men are not permitted to wear tee shirts, sandals or scuffs and must wear socks with shoes. Lady members and visitors are requested to use fashion discretion in the Clubhouse at all times.

Clean soft spike golf shoes may be worn in the Clubhouse except in the Royal Dining Room.

ON-COURSE

Club Policy requires all players to be neatly dressed. Golf shoes are to be worn on the golf course, metal spikes are strictly prohibited.

MEN

Tailored slacks or shorts are acceptable.

Shirts with a collar or turtle neck are acceptable, shirts must be tucked in.

Blue Jeans, cargo shorts and track suits are not accepted.

The wearing of dark/coloured socks is not permitted with shorts.

WOMEN

Modern, comfortable and functional apparel, with modesty and suitability and at the same time displaying style and modern flair suitable for the game of golf is accepted.

Blue jeans, singlets and sun tops are not accepted.

NOTE:

Garments with any advertising slogans (except for discreet brand name and Club logos) are not permitted.

The General Manager, Starter or Bar Stewards are the sole arbiters, and their decision is to be adhered to. Any variance to these regulations is at the discretion of the General Manager or his delegate.

Failure to meet our dress regulations may result in members/visitors not being permitted to play on the course or utilise the Clubhouse.
