



2014 AUSTRALIAN AMATEUR CHAMPIONSHIP EXPERIENCE

Terms and Conditions

1. Information on how to enter and prizes form part of these conditions of entry.
2. Entry is open to residents of Australia only. Employees of the Golf Australia and their immediate families and agencies associated with this promotion are ineligible to enter.
3. Promotion commences **11.00am 1 October** AEST and closes last email received **Friday 13 December 2013 11.59pm** AEST.
4. To enter tell us in 50 words or less **tell us why you would like to play at The Grange Golf Club and experience the atmosphere of the 2014 Australian Amateur Championship**. Also include your name, address, email and daytime telephone contact details. Entries must be submitted via the Entry Page on www.golf.org.au. Only one entry per person permitted. Incomplete entries will be deemed invalid and will not be included in the judging.
5. The Promotion will be judged by a panel of judges selected by the Promoter. Judging will commence on **14 December 2013** at the promoter's premises. Winners will be notified by email and phone using contact details provided in their entry on the **16 December 2013**. The names of and the winning entry will be published in the December 17 2013 edition of the Golf Australia Family E-News. This is a game of skill, chance plays no part in determining the winner. Each entry will be individually judged based on literary and creative merit. The judges' decision in relation to all aspects of the Promotion is final and binding on all who enter. No correspondence will be entered into.
