OPEN HANDICAP TEAM AGGREGATE "CHRISTOPHER COOK CUP". Played over 18 holes on Wednesday of the Tournament open to teams of three (3) players with any number of teams **from the same Club from which entries are received**. Players may form and nominate their own teams on day of play. Fee per team \$1.00. Entries must be received prior to team commencing play on Wednesday.

OPEN SCRATCH TEAM. Played over 18 holes on Wednesday. Any number of teams of two (2) players from the **same Club**. The total of the two (2) scores shall constitute the team score. Players may form and nominate their own team on the day of play and hand in **PRIOR TO TEAM COMMENCING PLAY**. Entry fee \$1.00 per team. Minimum of three (3) teams to hold the event.

**CONDITIONS OF PLAY**

- 1 Open to full playing Amateur Women and Junior Members who are holders of GA handicaps.
- 2 Handicap Divisions: Please note handicap limits for all divisions will be determined after the close of entries in order to equalise all divisions. Handicap print-outs must be shown on request. No entries will be accepted from players on Club handicaps.
- 3 The Match Committee shall make all arrangements and shall have full power to alter or make any variations to the conditions or programme should it deem it desirable and to cancel the event if insufficient entries are received.
- 4 Competitors are requested to report to the starter **20 minutes** before the appointed time given in the draw.
- 5 The Match Committee reserves the right to fix and alter starting times.
- 6 All disputes shall be settled by the Match Committee whose decision shall be final. Any member of the Match Committee competing in the Tournament may assist the Match Committee but is ineligible to represent the Match Committee with regard to any dispute or decision on the Rules of Golf within the division in which she is a competitor.
- 7 The Rules of Golf and the Local Rules of the Club at which events are played, shall be the rules of play during the Tournament.
- 8 Reduction/increase in handicap. If a player increases or decreases her handicap after the closing date for entries she will play in the division in which she has been drawn for the duration of the Tournament but compete in her correct handicap division. If a competitor reduces/increases her handicap after the first round of the competition within a specific division, her reduced/increased handicap shall apply to the 18 & 36 holes handicap events.
- 9 Players shall start at the time laid down by the Committee. The penalty for breach of Rule 6-3a is disqualification. However, it is a condition of the event that in the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7 if a player arrives at her starting point ready to play within five minutes after her starting time. The penalty for failing to start on time is loss of the first hole in match play or two strokes at the first hole in stroke play instead of disqualification.
- 10 Players may not engage professional golfers as caddies.
- 11 Ties: In the event of a tie for the N&NWDLGA Open, Closed Championships, Kath Hart Salver, Betty Cross Salver, Champion of Champions, Hart Jug and Open Foursomes Championships, the winner shall be decided by play-off over holes to be decided by the Match Committee. Runners-up in these and all other events shall be decided by G.A.Countback.
- 12 To qualify for N & NWDLGA Closed Events, a player must be resident within the Association and shall have been a resident of her home Club for at least three months prior to the Tournament, excluding students out of the district furthering their education whilst still a member of a home Club in the N & NWDLGA.
- 13 If a field cannot be accommodated on course, maximum handicap may be reduced.
- 14 Dress Regulations: It is the responsibility of competitors to know and comply with the dress regulations stipulated by the venue Club. Neat golfing attire. Soft spikes only.
- 15 **Mobile Phones** permitted to be carried **BUT must be in SILENT MODE. Penalty disqualification.**
- 16 **Distance Measuring devices** - these must measure **distance only** otherwise the **penalty is disqualification.** Devices are to be sighted by the starters before play commences.
- 17 SCORE CARDS must be lodged within 30 minutes of player's completion of play each day. PAIRS AND TEAMS CARDS to be returned on completion of play each day.
- 18 Players paying Block Entry not indicating intention to participate in Foursomes will not be permitted to take place in the field after the draw is completed. If wishing to play and requiring a partner, must indicate "partner required". If no partner is available at time of the draw, player may then take part in the field if there is a drop out due to illness only.
