

NSW Fourball Championship Participant Competition

Terms & Conditions

Condition of Entry

- 1. Information on how to enter the NSW Fourball Championship Participant competition form part of these conditions of entry (Competition).
- 2. By participating in this Competition, entrants agree to be bound by these conditions of entry.
- 3. The promoter is Golf NSW Limited ("Promoter") ABN 48 001 642 628 of 1a Duncan Street, Arncliffe NSW 2205 (**Promoter**).
- 4. Entry is open to all NSW amateur golfers, who are residents of NSW or ACT, and have paid an Entry Fee of \$5 to participate in their club qualifying event for any of the NSW Men's Fourball Championship, the NSW Women's Fourball Championship, or the NSW Mixed Fourball Championship, and are over the age of 18.
- 5. Event participants who have played in their club qualifying event for any of the NSW Fourball Championships held from 1 January 2015, and which may have occurred prior to the commencement of this Competition, are able to enter the Competition providing the Conditions of Entry set out in clause 4 have been met.
- 6. Each participant will be entitled to one entry only into the Competition, irrespective of whether they have participated in either the Men's or Women's Fourball Championship and then in the Mixed Fourball Championship.
- 7. All entries into the Competition will only be validated once the participant details are received by the Promoter from their participating club and thereby confirming an entry into the Competition.

How to Enter

- 8. Eligible participants must complete the Entry Form online at www.golfnsw.org
- 9. All required fields contained on the Entry Form must be completed for the entry to be deemed valid.

Eligibility

- 10. Employees and Board Members of the Promoter ("Employees") and such Employees' immediate family members, employees of Mazda Australia Pty Limited ABN 78 004 690 804 of 385 Ferntree Gully Road Mount Waverly VIC 3149 and any of its affiliate companies including but not limited to each State Office and each of its Dealer businesses, are not eligible to enter.
- 11. The Promoter reserves the right to verify, at any time during or after the closing of the Promotion, the validity of all entries and reserves the right, in its sole discretion, to disqualify any entrant who submits incomplete, indecipherable, or illegible entries or tampers with the entry process to enter the Competition repeatedly.
- 12. Entrants must notify the Promoter in writing of any changes of email address or phone number.
- 13. Winners who cannot be reached at the email address or phone number provided on their entry will be disqualified.
- 14. The Promoter reserves the right to:
 - a. verify the validity of entries and entrants including an entrant's identity, age and place of residence;
 - b. verify that the entrant has participated in a Club qualifying event and has paid the relevant Entry Fee for participation in the Event; and/or
 - c. disqualify any entrant who submits an entry that is, in its reasonable opinion, not in accordance with these conditions of entry.

Duration of the Competition

- 15. The marketing of the Competition will commence at 9am (AEST) on Monday 4 May 2015
- The Competition closing date for completion of Entry Form details will be 3:59pm (AEST) on Friday 30 October 2015.

Draws and Prizes

- 17. There will be one draw for the Competition prize, which will be conducted at 1a Duncan Street, Arncliffe NSW on Tuesday 1 December 2015 at approximately 11am (AEST) in the presence and supervision of an independent scrutineer.
- 18. The first valid entry drawn from the total number of entries received, will win a Mazda3 Neo Manual Hatch motor vehicle. Prize includes the standard features of such a vehicle and be available in a range of standard colours. The winner is responsible for their own travel arrangements to a Sydney location to take delivery of the prize. The Promoter will liaise with Mazda Australia to nominate the dealership or location where the vehicle will be made available to the winner, which must be collected by 1 March 2016.
- 19. The prize is valued at \$24,224 and is correct at time of printing and the Promoter accepts no responsibility for any subsequent variation in the prize value. The winner shall have the opportunity of accessorising the vehicle, including the selection of automatic transmission with such upgrading costs to be at the winners expense.
- 20. If there is an event beyond the control of the Promoter which prevents or hinders the conduct of the Competition or the Promoter's ability to deliver the prize to the winner, then the Promoter subject to the regulatory authority approval may in its sole discretion cancel the competition. Further, the Promoter may at its sole discretion recommence the Competition under the same conditions. The value of the prize is the nominated retail sale value for this vehicle provided by Mazda Australia, and is in Australian dollars.
- 21. Prizes are not exchangeable, transferable or redeemable for cash. The Promoter's decision is final and no correspondence will be entered into with entrants.

- 23. If for any reason the winner cannot be notified or does not take delivery of the prize by 1 March 2016, or chooses not to participate in the promotion, then the prize will be redrawn from all entries received during the Duration of the Competition and will take place at 11am on 2 March 2016.
- 24. Should a redraw be required, the winner shall be notified by e-mail and/or phone and must collect the prize by 1 April 2016.
