

TOURNAMENT CONDITIONS

1. The competition shall be played in accordance with the Rules of Golf as adopted by the Royal & Ancient Club of St. Andrew's, Scotland, subject to the modification hereafter mentioned and the local rules of the Mowbray Golf Club Inc. If a dispute arises on any point it shall be decided by the Tournament Committee of the Mowbray Golf Club Inc., from whose decision an appeal shall lie to the Executive Committee of N.G. Provided same is lodged in writing through the Secretary of the Mowbray Golf Club Inc. Within 7 days from the date of such decision. The Executive committee's decision on the matter shall be final.
2. **The Tournament Committee** to make all arrangements and have full power to alter or make any variation in the conditions of program, should they deem it advisable.
3. Should two or more competitors tie for the 36 hole scratch event, they shall replay the event, hole by hole, until a decision is reached. In the event of a tie for all other scratch and handicap events they will be decided by count back.
4. **Motorised Transport** - During play it is prohibited for a player to ride in or on a motorised vehicle unless permitted by a member of the Match Committee. Permission will only be granted to entrants who, for medical reasons, normally use a vehicle at their home club. Attach home club endorsement to this effect to a written application.
5. **GPS Measuring Devices** - A player may obtain distance information using a device that measures distance only. If during a stipulated round, a player uses a distance measuring device that is designed to gauge or measure other conditions that might affect his play (e.g.. Gradients wind speed, temperature, etc) the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such additional functions are actually used.
6. All competitors will be made Honorary members of the Mowbray Golf Club from **31st January 2016 to 4th February 2016.**
