



Golf NSW Membership Promotion Competition

Terms & Conditions

Condition of Entry

1. Information on how to enter the Golf NSW Membership Promotion competition form part of these conditions of entry (**Competition**).
2. By participating in this Competition, entrants agree to be bound by the conditions of entry.
3. The promoter is Golf NSW Limited ("Promoter") ABN 48 001 642 628 of 1a Duncan Street, Arncliffe NSW 2205 (**Promoter**).
4. Entry is open to amateur golfers, who are residents of NSW or ACT, and have paid their annual golf club membership subscriptions at a Golf NSW affiliated club between January 1, 2016 and the first day of competition of the 2016 NSW Open Golf Championship, and are over the age of 18.
5. Each participant will be entitled to one entry only into the Competition, provided their golf club membership allows for access to an official Golf Australia handicap.
6. All entries into the Competition will only be validated once the participant details are confirmed with the Promoter by a participating and affiliated club and thereby confirming an entry into the Competition.

How to Enter

7. Eligible participants must complete the Entry Form online at www.golfnsw.org
8. All required fields contained on the Entry Form must be completed for the entry to be deemed valid.
9. Golf NSW affiliated clubs will be required to confirm the relevant details of their current and financial members wishing to be entered into the Competition, subject to Clause 4.
10. Entries are to be received by 5.00pm ADST on the first day of competition of the 2016 NSW Open Golf Championship.
11. Eligible participants will be entered into the Competition once the details of their membership are received by the Promoter from a Golf NSW affiliated member club.
12. All required fields contained on the Entry Form must be completed for the entry to be deemed valid.

Eligibility

10. Employees and Board Members of the Promoter ("Employees") are ineligible to enter.
11. The Promoter reserves the right to verify, at any time during or after the closing of the Promotion, the validity of all entries and reserves the right, in its sole discretion, to disqualify any entrant who submits incomplete, indecipherable, or illegible entries or tampers with the entry process to enter the Competition repeatedly.
12. Entrants must notify the Promoter in writing of any changes of email address or phone number.
13. Winners who cannot be reached at the email address or phone number provided on their entry within seven (7) days of the prize draw will be disqualified.
14. The Promoter reserves the right to:
 - a. verify the validity of entries and entrants including an entrant's identity, age and place of residence;
 - b. verify that the entrant is a current and financial member of the Golf NSW affiliated golf club stated in their entry; and/or

- c. disqualify any entrant who submits an entry that is, in its reasonable opinion, not in accordance with these conditions of entry.

Duration of the Competition

15. The marketing of the Competition will commence at 12am (ADST) on Sunday 31 January 2016.
16. The Competition closing date for completion of Entry Form details will be 5.00pm (ADST) on the first day of competition of the 2016 NSW Open Golf Championship.

Draws and Prizes

17. There will be one draw for the Competition prize, which will be conducted at Stonecutters Ridge Golf Club, Stonecutters Drive, Colebee NSW on the third day of competition of the 2016 NSW Open Golf Championship at approximately 1pm (ADST) in the presence and supervision of an independent scrutineer.
18. The first valid entry drawn from the total number of entries received, will win one (1) round of golf (18 holes) for three people, including the use of motorized carts and lunch at New South Wales Golf Club in the company of Ms. Deborah Hutton. Competition winners whose permanent residential address is greater than 300km from New South Wales Golf Club will also receive airfares and 1 x nights' accommodation for three (3) people included in the prize.
19. The prize is valued no more than \$9,000.00 and is correct at time of printing and the Promoter accepts no responsibility for any subsequent variation in the prize value.
20. If there is an event beyond the control of the Promoter which prevents or hinders the conduct of the Competition or the Promoter's ability to deliver the prize to the winner, then the Promoter subject to the regulatory authority approval may in its sole discretion cancel the competition. Further, the Promoter may at its sole discretion recommence the Competition under the same conditions.
21. Prizes are not exchangeable, transferable or redeemable for cash. The Promoter's decision is final and no correspondence will be entered into with entrants.
22. The winner will be notified by e-mail and/or phone and their name will be published on www.golfnsw.org on 22 November 2016. Only the winner will receive written notification.
23. If for any reason the winner cannot be notified or does not claim the prize by 1 June 2017, or chooses not to participate in the promotion, then the prize will be redrawn from all entries received during the Duration of the Competition and will take place at 11am (AEST) on 2 June 2017.
24. Should a redraw be required, the winner shall be notified by e-mail and/or phone and must collect the prize by 1 July 2017.

By entering this competition, entrants consent to the Promoter to use the entrants personal information including name, image, mobile phone number, email address and any other information provided to the Promoter by the entrant pursuant to this Competition, in whole or part, in any media and in any manner whatsoever, without remuneration, limitation or restriction, including for promotional and advertising purposes to promote the Promoter, its business and related companies.
