1. Introduction, Welcome & Apologies not noted above

Chris Allen welcomed those in attendance and noted the apologies for this meeting. He also gave special welcome to Maggie O'Donnell and Bob Soper who were present for the meeting.

2. Confirmation of Minutes of Previous Meeting

- 2-1 The Minutes of the Council meeting held on Tuesday 28th July, 2015 were approved.
- 2-2 It was noted that the Business Arising from the minutes was dealt with later in the agenda.

3. Chairman's Update

Chris Allen noted that he, John Robinson and Andrew Tharle attended the Golf Australia AGM on Sunday 24th October in Melbourne. The One Golf matter was discussed at the meeting, including the future if the project was to proceed and a second meeting about general Governance issues. The Chairman advised that at this stage there are still a large amount of questions that need to be answered. John Robinson further explained that each State is very different to the other and much care and consideration is being taken when reviewing all aspects of the proposal. Finances, constitutions, staffing and Boards are just some of the major concerns that are being raised.

The Chairman advised that Sue Fabian's nomination for the Golf Australia had been unsuccessful unfortunately, one of the states that had indicated their support prior to the election were not forthcoming with their vote. There was a special resolution at the GA AGM, to prohibit the CEO of GA from representing on the Board for a minimum 3 years after his employment contract.

MyGolf – The Chairman advised that approximately 65 out of 100 kits had been allocated under the Golf NSW scheme which is funding the kits for clubs whom apply.

4. CEO Report

Stuart Fraser spoke of:

- Club Support Service Now has Preferred Service Providers who in conjunction with Golf NSW and the Club Support Program can further assist member clubs. They include:
 - Paynter Dixon Construction & Property Development
 - Go Energy Solar & Retail Energy Solutions
 - Thomson Geer Legal Services

Stuart Fraser also advised the Council that Golf NSW is in the process of developing a cost effective website solution for clubs to purchase and promote their clubs. Many clubs, particular the smaller regional clubs have very outdated websites and GNSW is looking to be proactive by signing a deal with a website provider, who will then provide up to date and fresh websites for around \$1000 to member clubs and Districts. Websites are a key successful businesses these days and these include our member clubs in NSW. Insurances is another area in which GNSW is looking in to, to help with cost savings along with general accounting education ie: some clubs are not required to be fully audited, the smaller clubs making less than \$250,000 do not need to spend money each year on a full audit. Council Members were reminded to encourage clubs to contact GNSW if they are struggling to use the free Club Support Service.

- Strategic Plan Update Key achievements
 - Expansion of Club Support Services now including agronomy and grants advice
 - Launched Small Club Bench Marking Tool
 - Successfully launched the Buddy Club Program now have 126 clubs in the program
 - Implemented a new in house Tournament System GolfBox
 - New Customer Relations Management System (CRM) database
 - Secured Corporate Partners and Service Providers
 - Employed a Digital & Media Manager David Tease
 - Completed a facilities review for the Minister of Sport
- Secured funding from local Councils to host golf tournaments in their council areas
- TV Commercial being made for all the services golf clubs can offer ie: golf, functions, meetings etc. The ad will include Deborah Hutton and Brad Fitler giving it a high profile.
- Commenced work on the Golf NSW website
- Working on a Social Golf Program
- MyGolf program improving with more involvement.
- NSW Open's with the NSW Men's Open to be held 12 to 15 November at Stonecutters Ridge, The Minister of Sport announced that NSW Government will be supporting the event for the next 4 years. This year's lead up included Country Qualifying events which gave winners of selected regional tournaments entry into the NSW Open Championship.
- Golf Australia initiatives this year they launched "Golf Month" to replace Play Golf Week. GNSW will be reviewing the program after the NSW Open.

Sue Fabian spoke to the paper which had been circulated regarding:

- A. The Change to the Role of the Golf NSW Council
- B. Changing the Method of Electing Directors and Preserving Constitutional Protections for Golf NSW
