

GOLF MONTH PARTICIPATION COMPETITION

TERMS & CONDITIONS

1. Information on how to enter and prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is free and open to Australian residents, aged 18 and above. Employees and their immediate families of the promoter, their related corporate bodies and Agencies are not eligible to enter this promotion. The Winner's travel companion must be 16 years of age.
3. The promotion commences at 12.01am AEST on 1 October 2016 and closes 11.59pm AEST on 31 October 2016.
4. To enter, entrants are required to participate in a Golf Month activity at a participating Golf Month club or facility within the Competition period.

By participating in a Golf Month activity during the Competition Period you will be automatically entered into the Competition. Entries will be received by Golf Australia by the participating Golf Month club or facility on behalf of entrants via the nominated entry form.
