# **2016 NSW OPEN GOLF CHAMPIONSHIP – ATTENDANCE PROMOTION**

# **CONDITIONS OF ENTRY**

## **General**

- 1. Information on how to enter the 2016 NSW Open Attendance promotion and prizes form part of these conditions of entry.

Those spectators who then attend the event, and present their ticket at the registration desk at Stonecutters Ridge Golf Club, will go into a draw to win the prize. Only one entry per person, per day is permitted.
