

2016 Election of Directors to the Board of Golf NSW Limited

Dear Club and District Presidents, the guidelines below provide information and direction regarding voting in the 2016 Election of Directors.

Following changes to the Golf NSW Constitution as outlined in recent correspondence from the Chairman, the election of Directors to the Board of Golf NSW is now the responsibility of Clubs and Districts.

Nominations have been received for the Election of Directors. Based on the nominations received, Meralyn Fage was the only female candidate nominated whose principal place of residence was outside the Sydney Metropolitan Area. Accordingly, pursuant to Rule 33 of the Constitution, Meralyn Fage will be elected unopposed to fill this position on the Board. Two of the positions on the Board are already filled by Andrew Tharle and Michele Adair who shall hold office until the conclusion of next year's Annual General Meeting (subject to the Constitution). Accordingly, a ballot is required to elect the six remaining Directors to the Board from the eight candidates.

The Election of the Directors of Golf NSW is a crucial part of our governance processes and I would encourage each of you to take an active role in the election and ensure you lodge your vote by 4:00pm on Monday 14 November, 2016.

VOTING GUIDELINES

How to vote:

- You may vote on the election of Directors by submitting your vote in accordance with the two options below;
- You may vote for up to, but for no more than, six (6) candidates.

OPTION 1: BALLOT PAPER:

Using the enclosed Ballot Paper, place a mark, eg. X in the box opposite the name of the candidate(s) of your choice.

- Do not put any mark or writing on the Ballot Paper by which you can be identified.
- Print and sign your name in the space provided on the outside flap of the return envelope addressed to The Returning Officer, Golf NSW, then seal;
- You may return the ballot paper via email: <u>elections@golfnsw.org</u>, noting your name and Club in the email.
- In order for your vote to be valid, the envelope containing the Ballot Paper must be signed
 as above and it must be received by the Returning Officer <u>before 4.00pm on Monday 14</u>
 November 2016.
- In order for your vote to be valid, the Ballot Paper must be completed as outlined above, and the envelope must be completed and signed as outlined above and be received by the Returning Officer <u>before 4.00pm on Monday 14 November 2016</u>.

In order for your vote to be valid, it must be submitted <u>before 4.00pm on Monday 14</u>



Background / Expertise:

My employment and volunteer experience covers most of the skills, qualifications and experience sought for a Director on the Golf NSW Board, and I believe I am well-prepared to contribute in nearly all of the Board's key roles.

- Most recently, from 2003 until December 2015, I held various corporate management and Board-related roles with the not-for-profit professional association Engineers Australia, latterly as Adviser Strategy and Governance. During that time I instituted many highly-regarded governance innovations:
- _o I developed 3 successive strategic plans, following significant consultation periods across the office bearer network and the broader membership.
- _o I wrote a comprehensive Board Charter handbook, based on the 10 components of the AICD's 2013 publication *Good Governance Principles and Guidance for Not-for-Profit Organisations*.
- o In support of a committee of office bearers, I delivered a campaign including a substantial communication program and an international online membership ballot to achieve fundamental governance reform of Board composition and selection of Board directors. For the success of this work, I was awarded the Engineers Australia President's Prize for 2015.
- o I designed and implemented an organisation-wide corporate performance reporting system, keyed to the priorities in the strategic plans. These reports fed into the organisation's Annual Reports to members. Our online report in 2009 was the national winner for online reporting at the Australasian Reporting Awards.
- From 1982 to 2002, I served as a senior executive in the Department of Defence. I was the Chief of Navy's resources and financial adviser from 1997 to 2002, I created and led the organisation responsible for strategic management of the national defence real estate portfolio from 1991 to 1995, and from 1982 to 1987 I was responsible for managing the five-year Defence financial plans, culminating each year in the Minister's annual Defence Budget submissions to Cabinet.

- As a member of the ACT Monaro DGA Committee from December 2013 to the present:
- o **Four-year Plan.** Following personal visits to many of the District's member clubs during 2014, I prepared (with suggestions from the District Committee members) a four-year plan of key objectives and priorities for the District Association Committee, including a simple set of financial management principles. The plan was presented to the District's member clubs for any feedback prior to adoption. It covers the period 2014-2018 and was prepared with the intention of exploring initiatives for the Committee beyond its traditional focus on senior and junior golf competitions.
- o **Golf Forum.** On behalf of the Committee, I organised and convened our first District Golf Forum in April this year in Canberra. The forum drew together 45 golf leaders and administrators at board/management committee level to engage on current golf club operational issues, on the potential for improved marketing of golf in the region, and on development of the sport through particularly junior golf programs and competitions. Key presenters included the CEO of Golf NSW and representatives of the Australian Sports Commission, Jack Newton Junior Golf, and School Sport ACT. Feedback suggests the forum was received very favourably by attendees and successfully achieved its goals.
- As a member of my golf club Match Committee from July 2012 to the present:
- o **Course Setups.** Drawing on the R&A publications, I introduced a systematic approach to rotation of pin and tee setups right through the annual fixtures calendar to satisfy both Match Committee and Course Superintendent needs for a reliable weekly schedule. The full set of course setups is available to members online.
- o **Annual Fixtures Calendar.** I am responsible to coordinate and prepare the club's daily fixtures program into an annual calendar published for members. This entails coordination with District and State-level programs, course facility management programs, and the schedules of kindred golfing bodies.
- o **Volunteer Role Statements.** I have initiated a system of role statements and checklists across the full range of Match Committee responsibilities to help manage the induction of new volunteers as they are elected to the committee into the future.
- Rules. I gained State-level accreditation in September 2013. Apart from officiating at District competitions, where I introduced a pace-of-play regime which has been picked up at several clubs, I contribute a 'ruling of the month' to my club's monthly newsletter to members, based on typical situations experienced at the course.

NOMINEE'S STATEMENT

As for many club-level golfers, and with my previous work commitments, I enjoyed the amenity of my golf club membership for many years without paying great regard to the essential voluntary contributions made by many of my fellow club-members.

During 2012, I made a decision to make a stronger contribution of my own to the ongoing success of my own club. I've enjoyed the opportunity immensely and this led me to pursue State-level rules accreditation and to make a contribution at the District Committee level, as I've described above.

The greatest attraction for me in seeking to join the Golf NSW Board is the challenge of dealing with the myriad and complex pressures confronting the sport, as part of the national structure charged with leadership of amateur golf in Australia. Given the day-to-day financial and operational pressures faced by most volunteer-based golf clubs, I would like to see the initiatives set out in Golf NSW's current strategic plan, in relation to club support in its many forms, given added emphasis.

I am confident I have the strategic and governance skills, and the demonstrated commitment to working with others to deliver effective outcomes, which are necessary to work successfully as a Board member.

I understand very well the obligations and roles of a Board Director, and the delineation of responsibility from the CEO. I also understand very well the leadership required through Board committees, which provide the opportunity to not only engage with the many stakeholders in the golf sector and at club level which may be key to Committee issues, but also to develop good working relationships with the CEO's team along the way.
