#### PRESIDENT'S REPORT

2015-16 has been another good year for Golf NT with increased NT wide club memberships up by 4.4% and the number of competition rounds up 0.10%.

However things could be different in 2017 with the NT Economy starting a downward trend and we need to be up for the challenges we face in the future. Golf NT is here to support the clubs and help them succeed.

Golf NT has continued with Tier 1 status (and securing a healthy increase in funding) after meeting all our KPI's under the NT Government Sports funding agreement. We also had Golf Australia meet with the NT Dept. of Sport during the year to discuss the progress of the One Golf concept, which was very fruitful to all parties.

The development of golf in the NT has continued to build and gain momentum under the Development & Hi-Performance committees. Brett Rankin has been instrumental in this area particularly in the School Development programmes. The NT Golf, Golf NT Junior Academy and the continued participation of NT representative teams at the Australian Junior Championships have all been very successful during the year.

Our own NT Men's and Women's Amateur Championship were well supported by interstate and local talent and a big thanks to the Tournament Committees of both Alice Springs and Darwin Golf Clubs (Full results are mentioned later in this report).

It was pleasing to see that the Palmerston Golf club in conjunction with the PGA hosted the inaugural NT PGA tournament with international, national and local representatives. Congratulations to all involved.

Golf NT's finances have improved under the guidance of Sandy Ford and Vicki Bridge. The continued support of the NT Government, Channel 9 and the Carbine Club of the NT is greatly appreciated for their generous assistance.

A big thank you to all our sponsors for their continued long and loyal support (who are all acknowledged later in this report).

Farewell to Daynor Trigg, Vice President who is retiring to Tasmania and would like to thank all the Committee members for their contribution, our staff, Brett Rankin (Golf Operations Manager) and Vicki Bridge (Office Manager) for their continued support and contribution to another successful year for Golf NT.

#### **Report on the Financial Report**
