# 2016-17 STATE TEAM NOMINATION AND PLAYER AGREEMENT

I \_\_\_\_\_\_ confirm that I am available for selection in the 2017 state team for which I am eligible and hereby agree to abide by the terms of this agreement.

I understand that should I breach of any of the conditions of the agreement my eligibility for, or position in the team, shall be reviewed by Golf Tasmania.

By signing this agreement, I make a commitment to undertake squad and personal training as directed by the team coach or team manager and to the goals of Golf Tasmania to win the Australian Interstate Teams Matches.

#### 1. Playing and Training Commitment

- 1.1 I understand that the respective order of merit forms the basis for team selection. I have read the order of merit conditions and commit to fulfilling the qualifying requirements.
- 1.2 I agree to attend all training sessions called for that purpose by the team coach or team manager.
  1.2.1 If for any reason, I am unable to attend then I shall contact the team coach or team manager in advance.
  - 1.2.2 Golf Tasmania will bear the cost for state team members travelling to training sessions out of area under the following condition:
    - (i) Team members are expected to travel together and thereby minimizing unnecessary expenditure.
- 1.3 I agree that additional and specific category training/evaluation sessions may be on-charged to players at a rate of no greater than fifty percent (50%) of the actual incurred cost of the program.

## 2. Behaviour

As a member of the state team:

- 2.1 I will abide by code of conduct prescribed in the Golf Australia Member Protection Policy.
- 2.2 acknowledge that I am expected to maintain a high standard of behaviour both on and off the course. I understand that my behaviour reflects my commitment to my position on the team, my team mates and to the tournament or training. I acknowledge that poor behaviour illustrates I am not committed to performing to the best of my ability. I also understand that as an identified member of a state team my behaviour and actions will potentially come under a higher level of review from my peers and the golfing community.
  - 2.2.1 A team member who exhibits poor behaviour or acts inappropriately on or off the course may be expelled from the team and such may impact on future team selection.

## 3. Dress and Equipment

I agree that should I be selected in a state team I will:

- 3.1 wear the state playing uniform while attending official training and when playing in the Australian Interstate Teams Matches.
- 3.2 utilise the Golf Tasmania supplied or endorsed golf bag, headwear and umbrella while playing as a state representative.
- 3.2 when travelling, attending official functions, including presentations, wear the full-dress uniform including jacket, shirt and tie. Jeans are not acceptable for any of these events, regardless of host club regulations.
- 3.3 be issued with the official state blazer which will remain the property of Golf Tasmania and return in good condition following the conclusion of the Australian Interstate Teams Matches. All other items of uniform may be retained by the players

# 4. Flights & Excess Baggage

- 4.1 State team members will be offered the opportunity to nominate alternate flights to or from the capital city of the Australian Interstate Teams Matches as required. Any additional cost will be incurred by the individual.
- 4.2 Golf Tasmania will bear the cost of baggage for travel of representative players including golf clubs and golf bag and an additional piece of baggage. Costs incurred by any excess will be at the player's own expense.

# 5. General

- 5.1 I agree to inform the team coach or team manager as soon as practical should circumstances change and I become unavailable or unable to fulfil my commitments to the team.
- 5.2 I agree to inform the team coach or team manager as soon as practical of any injury or other health issue that may impact my ability to undertake training or perform at the tournament and disclose the advice of my medical professional as to treatments and rehabilitations. If requested, I shall undertake fitness appraisals from the associations nominated sports medicine representative and will commit to the specified physical and dietary requirements and recommendations made.
- 5.3 I agree not to promote companies that are in direct opposition with Golf Tasmania's major sponsors.
- 5.4 I agree that if required by Golf Australia, Golf Tasmania, the Australian Sports Drug Agency or the Australian Institute of Sport I shall submit to one or more doping control examinations for the presence of doping substances or techniques in accordance with the Golf Australia Anti-Doping Policy or such other applicable doping guidelines and that the results of any doping control examinations or drug tests may be communicated to Golf Tasmania and the player hereby releases Golf Tasmania, Australian Sports Drug Agency or Australian Institute of Sport from any claim, cause of action, suit, demand or liability in respect of so communicating these results.
- 5.5 I understand that this agreement shall remain in force from announcement of the team until the completion of the respective Australian Interstate Teams Matches, subject to amendments to training schedules.
- 5.6 I confirm that I am an amateur golfer in accordance with the Rules of Amateur Status as laid down by the R&A Rules Ltd. I shall continue to conform with the Rules of Amateur Status for the duration of this agreement.
- 5.7 I confirm that I am a full financial member of a Golf Tasmania member club.
- 5.8 I agree to pay a state team levy of three hundred dollars (\$300.00) which is due before the allocation of my team uniform at a date to be confirmed. Failure to pay will result in surrendering the position on the team.
- 5.9 I acknowledge that I may be requested to play in special events or assist with exhibition that may be of benefit to Golf Tasmania.
