

# 2017 GOLFING NSW NEWSLETTER – MONTHLY COMPETITIONS

## CONDITIONS OF ENTRY

### General

1. Information on how to enter the Golfing NSW Newsletter promotions and the prizes form part of these conditions of entry.
2. By participating in this Promotion, entrants agree to be bound by these conditions of entry.
3. The promoter is Golf NSW Limited ("Promoter") ABN 48 001 642 628 of 1a Duncan Street, Arncliffe NSW 2205.
4. The Promotion period will be the full year of 2017, and entries for the first month will be accepted from 7am on Thursday, February 16<sup>th</sup>, 2017 and entries will close at 6.00pm AEST Thursday, March 9th 2017 ("Promotional Period"). This will be repeated each month for the duration of the year.
5. Entry is open to all subscribers of the Golfing NSW Newsletter.

### How to Enter

6. To enter the February Promotion, subscribers must share the Golfing NSW Newsletter with a friend by clicking on the "Forward to a Friend" link in the newsletter. A winner will then be selected via computer "Random Picker".

Each month, the format of the competition will vary slightly.

### Eligibility

7. Employees of the Promoter ("Employees") and such Employees' immediate family members, or its affiliate companies are not eligible to enter.
8. The Promoter reserves the right to verify, at any time during or after the closing of the Promotion, the validity of all entries and reserves the right, in its sole discretion, to disqualify any entrant who submits incomplete, indecipherable, or illegible entries or tampers with the entry process or uses any automated entry software or any other mechanical or electronic means that permits the participant to automatically enter the Promotion repeatedly.
