## JUNIOR PRO-AM

### Conditions of Entry

1. **THE NSW OPEN JUNIOR PRO AM:** Is scheduled to be played over 18 holes team stableford at Twin Creeks Golf & Country Club.
2. **COMPETITORS:** Wherever possible, teams will consist of three amateurs and one professional (or amateur who is entered in the NSW Open Golf Championship). Players may request to play with other amateurs and these requests will be granted, wherever possible, at the discretion of the Championship Committee.  
Each participant will represent and must be nominated by an official from a NSW Golf Club, although this Club may not be the player's Home Club.
3. **CHAMPIONSHIP COMMITTEE:** The NSW Open Pro Am will be under the management and control of the Championship Committee, consisting of five representatives of Golf NSW, one member appointed by the host club, and two members appointed by the PGA of Australia. In the absence of the full Championship Committee, such members thereof as may be present at any time may give a decision and any decision shall be deemed the decision of the full Championship Committee. The Championship Committee reserves the right to vary any condition of this event.
4. **RULES:** The Pro Am will be played under the auspices of the PGA of Australia, in accordance with the 2017 PGA of Australia Member Regulations Handbook. This will include The Rules of Golf, as adopted by R & A Rules Limited, Local Rules and Conditions of Competition (PGA Tour Hard Card) as published by PGA Tour, and such additional Local Rules as approved by the Championship Committee.
5. **TIES:** A tie in the Pro Am will be decided using the Golf Australia Countback System.
6. **PROTESTS:** Any decision of the Championship Committee will be final in all matters relating to the NSW Open Pro Am.
7. **DRAW AND STARTING TIMES:** A draw for the day's play will be made and published. Players shall start at the time and in the order arranged by the Committee.
8. **PACE OF PLAY:** Pace of Play will be administered in accordance with the PGA of Australia's Pace of Play Policy as outlined on the PGA Tour Hard Card (Section 4).
9. **PRIZES:** The winners will be presented at the Official Function held at the conclusion of the Pro-Am.
10. **PUBLICITY:** Golf NSW, the PGA of Australia and Twin Creeks Golf & Country Club arrange publicity before and during the event in the press, by live and recorded radio and television broadcasting, by filming, and in electronic form. The players assent to references to them and pictures of them in practice and play appearing and being used for commercial purposes by the PGA of Australia, Golf NSW and Twin Creeks Golf & Country Club. All rights for televising live, television recordings or for any visual or electronic reproduction of the Championship are reserved only to the PGA of Australia, Golf NSW and Twin Creeks Golf & Country Club and may only be made under licence.
11. **MOTORISED CARTS:** All competitors will be walking during this event
12. **DISTANCE MEASURING DEVICES:** The specimen Local Rule on page 153 of the Rules of Golf permitting their use applies for all play during the PRO AM.
13. **ENTRIES:**
  - 13.1. All entries shall be subject to the approval of the Championship Committee who reserves the right to accept or refuse any entry without giving any reason for the decision which shall be final.
  - 13.2. Nominations are accepted at face value, on the basis that information contained therein is correct and up to date. Should this subsequently be proven not to be the case, the Championship Committee reserves the right to deem any competitor ineligible – at any time prior to or during the event.
  - 13.3. Entries will be date stamped on the date they are received and entries will be taken until the maximum number of entries (66) are received. Your entry is not considered received until your name appears on the event entry list on [www.golfnsw.org](http://www.golfnsw.org)
14. **REGISTRATION:** All competitors in the Pro Am must register at Twin Creeks Golf & Country Club at least 15 minutes prior to their start time. The Championship Committee reserves the right to waive this condition in special individual circumstances.
15. **PRACTICE:** Practice times prior to the event will not be available.
16. **DATABASE OF ENTRANT'S DETAILS:** The personal data contained in this Entry Form is permanently retained by Golf NSW. This data may be utilised by Golf NSW or its sponsors for the distribution of correspondence, in both electronic and hard copy means. From time to time players may be sent entry forms, event literature, the Golf NSW e-news, or marketing material by the sponsor(s) of Golf NSW events, or information about events conducted by golf clubs affiliated with Golf NSW or golf clubs affiliated with a NSW District Golf Association. Upon receipt by Golf NSW of a written request a player may either have access to their details, or have their details deleted from the database.
