

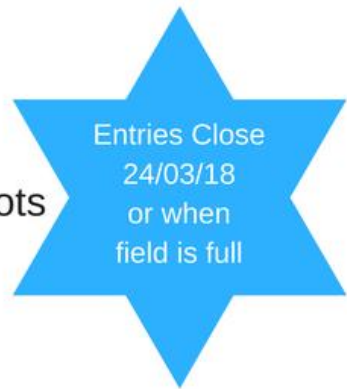

EASTER GENTSOMES CHALLENGE CONDITIONS

- 1.** Entries will only be accepted if they are on the Official Entry Form with Entry Fee enclosed. Refunds will not be made to an entrant scratching within seven days of the event.
- 2.** Entries will close on 24th March 2018. Entries should be addressed to:

- 3.** The Match Committee of Lonsdale Golf Club shall have the entire management of the Competition.
- 4.** Maximum Handicaps are 36 for Men and 45 for Ladies.
- 5.** In the event of ties, events will be decided on a count back as recommended by Golf Australia.
- 6.** Entries are restricted to amateurs who are members of Clubs operating under the auspices of Golf Australia, excluding players with Golf Access Handicaps.
- 7.** The Committee shall have the right to refuse the entry of any person without being required to give reason for such refusal.
- 8.** All players must supply their Golflink Number with entry form.
- 9.** Competitions shall be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Golf Club St. Andrews Scotland together with such local rules as are in force over the course over which the competition takes place. If a dispute arises on any point it shall be decided by the Match Committee. This decision shall be final. Provided however that the Committee if in doubt shall have the right to refer any such dispute to the Council of the Victorian Golf Association whose decision shall then be final.
- 10.** Any dispute or protest, must be lodged in writing with the Committee within 15 minutes after the last card is returned.
- 11.** The Committee has the power to temporarily alter a player's handicap in accordance with the Australian Handicapping system.
- 12.** The Committee may in the event of bad weather or for any other reason, either cancel the competition or fix another day.
- 13.** Non-members of Lonsdale Golf Club are not permitted to use their private motorised golf cart/bike on the course without prior permission from the club.
- 14.** Metal or hard spikes are not permitted.
