## Conditions of Play

1. Open to male amateurs whose Golf Australia Handicap does not exceed 4.4 (5), female amateurs whose Golf Australia Handicap does not exceed 12.6 (15) and male junior amateurs whose Golf Australia Handicap does not exceed 7.7 (9). Junior's must be under 18 years of age on the day of the event.
2. All three events are to be treated as separate events. Players may only enter one event, and this event will be as recorded on the entry form at the time of entry. A player may only win one trophy.
3. The entrance fee must be paid at the time of entry. Late entries will not be accepted.
4. The Glenelg Golf Club reserves the right to refuse any entry without giving an explanation. Any entrant may withdraw and have their entrance fee refunded provided notification is received prior to the date entries close.
5. The field for all events will be strictly limited to 72 players in total. In the event of entries exceeding this limit, a handicap ballot will apply, with entrants in the Golf SA Vardon and Junior Vardon trophies afforded priority.
6. Competitors must start at the appointed time. Rule 6-3 will apply.
7. The Match Committee of Glenelg Golf Club will make playing arrangements and be umpire in the case of a dispute or protest which must be lodged in writing with the Match Committee at the Clubhouse not later than 5 minutes after the conclusion of the day's play.
8. In the event of a tie in any of the three events, there will be a sudden death playoff.
9. Rule 6-7 will be strictly enforced. Each group must maintain its position on the course with respect to the group in front. Any group with a clear hole in front of them will be considered out of position. Penalties will be applied to players in such groups who by their pace contribute to such delay. Warnings may not be issued prior to imposition of penalties.
10. Competitors must play with a ball that is named in the current R & A and/or USGA approved lists.
11. Golf SA conditions in relation to Drug Testing and Code of Conduct apply.
12. Players and caddies are expected to observe the dress standards and any course requirements of Glenelg Golf Club.
13. By this application, the player consents to the use by Glenelg Golf Club, or persons authorised by Glenelg Golf Club, of their name, likeness, voice and references to them and photographs and other images of them and their play connected with their appearance in the event, or any portion(s) thereof, in connection with such media promotion, broadcasting and other exhibition and publication of the event.
