# 2018 MIXED FOURSOMES CHAMPIONSHIP OF TASMANIA - CHAMPIONSHIP CONDITIONS

## 1. Format

- 1.1 The Mixed Foursomes Championship of Tasmania will be played over 27-holes of stroke play, 18-holes on Sunday 11 November (am), and 9-holes on Sunday 11 November (pm), 2018.
- 1.2 The winners of the Mixed Foursomes Championship of Tasmania will be the Tasmanian Mixed Foursomes Champions and receive the Championship gold medals and hold the Championship cup for one year.

## 2. Championship Committee

- 2.1 The Championship will be under the management and control of the Championship Committee consisting of Tasmania Golf Club's Captain.
- 2.2 In the absence of the full Championship Committee such members thereof as may be present at any time may give a decision and any decision shall be deemed the decision of the full Championship Committee.
- 2.3 The Championship Committee will have sole management and control of the Championship, with full power at any time to alter or vary any one of the Conditions.
- 2.4 The Championship Committee decision on matters affecting the Championship will be final.

## 3. Rules of Play

The Rules of Golf, as adopted by R&A Rules Limited, will apply together with Local Rules as drawn up by the Championship Committee.

## 4. Eligibility

- 4.1 Eligible pairs are to consist of one male and one female player who possess a GA handicap.

## 5. Entries

- 5.1 The entrance fee for the Mixed Foursomes Championship of Tasmania is \$50.00 (Inc. GST) per pair.
- 5.2 Entrance fee must be paid at the time of entry and must be made on the attached entry form.
- 5.3 Entries must be made with the Secretary, Tasmania Golf Club, PO Box 425 Sorell, 7172 not later than 5.00pm on Friday 9 November, 2018. It is the sole responsibility of the entrant themselves to ensure that their entry is received prior to the closing time for entries.
- 5.4 The maximum field size for the Mixed Foursomes Championship of Tasmania is 84. In the event of applications exceeding the number of places available, entries for higher handicap competitors will be decided by handicap ballot. Unsuccessful entrants will be informed without delay and given the opportunity to compete if withdrawals subsequently occur. Entrance fees will be refunded to entrants balloted out, who do not compete.
- 5.5 Late entries may be accepted at the discretion of the Championship Committee.
- 5.6 Acceptable payments methods are only as follows – credit card, cheque (personal or bank), money order, cash (please note that Tasmania Golf Club will not accept responsibility for cash sent that is not received). Cheques or money orders are to be made payable to Tasmania Golf Club.
- 5.7 Entrants must conform in all respects to the Rules of Amateur Status, as adopted by R&A Rules Limited.
- 5.8 The decision of the Championship Committee as to acceptance or refusal of any entry will be final.

## 6. Conforming Golf Balls, Driver Heads and Time of Starting

The specimen conditions in the Rules of Golf are in effect as regards to Conforming Golf Balls, Driver Heads and Time of Starting.

## 7. Drug Testing

All competitors are subject to drug testing by the Australian Sports Anti-Doping Agency for banned substances as laid down in Golf Australia's Anti-Doping Policy. Any competitor infringing this policy, or refusing to take a test, will be disqualified and subject to any sanction(s) brought down by ASADA. ## 8. Practice

Practice will be available on Saturday 10 November.

## 9. Pace of Play

- 9.1 Rule 6-7 will be strictly enforced. Each group must maintain its position on the course with respect to the group preceding it. Any group with a clear hole in front of it will be considered out of position. Penalties will be issued to individuals in such groups who by their pace contribute to such delay. Warnings may not be issued prior to penalties.
- 9.2 A time allotment for the completion of each round will be allocated by the Championship Committee to assist with the pace of play.

## 10. Motorised Transport

During play, it is prohibited for a player to ride in or on a motorised vehicle unless specific written permission has been granted by the Championship Play Committee. (NB Subject to host club permission, a caddie may use motorised transport at any time.) Penalty: 2 strokes for each hole at which a breach occurred; maximum penalty per round – 4 strokes (unless permitted to ride by a member of the Championship Rules Committee).

Procedure when breach discovered: Use of any unauthorised form of transportation must be discontinued immediately upon discovery that a breach has occurred.

Note i: Permission will only be granted to entrants who can provide a Medical Certificate.

Note ii: GT takes no responsibility for the availability of golf carts.

Note iii: Permission will be granted on the basis that the following requirements are adhered to. Players failing to adhere to these requirements are liable to have such permission revoked:

Players who drive at a pace which is clearly quicker than walking pace; and/or who

drive to a point past their ball which is clearly unreasonable for a player who is not using motorised transport to reach, are in breach of these requirements.

Match-play – At the conclusion of the hole at which the breach is discovered, the state of the match is adjusted by deducting one hole for each hole at which a breach occurred; maximum deduction per round – two holes.

Stroke or Match-play – In the event of a breach between the play of two holes, the penalty applies to the next hole. Use of an unauthorised form of transportation must be discontinued immediately upon discovery that a breach has occurred. Otherwise the player is disqualified.

## 11. Distance-Measuring Devices

A player may obtain distance information by use of a distance-measuring device. If, during a stipulated round, a player uses a distance measuring device to gauge or measure other conditions that might affect his play (e.g. elevation changes, windspeed, etc), the player is in breach of Rule 14-3.

## 12. Code of Conduct

All entrants assent to be bound by Golf Tasmania's Code of Conduct. A copy of the code is available at [www.golftasmania.org.au](http://www.golftasmania.org.au)

## 13. Publicity

Tasmania Golf Club and the sponsors arrange publicity before and during the Championship in the press, by live and recorded radio, television broadcasting and by filming. The competitors assent to reference to them and pictures of them in practice and play being used for commercial purposes by Tasmania Golf Club and the sponsors. Tasmania Golf Club reserves the right to any press, broadcasting or television fees paid or payable for permission to broadcast, photograph or televise play.

## 14. No Smoking

All competitors and caddies are subject to State Government laws prohibiting the smoking of cigarettes, cigars or the like during the course of any round played in a competition.
