## CONDITIONS

1. Competitions shall be played in accordance with the Rules of Golf as adopted by the Royal and Ancient Club of St Andrews, Scotland, subject to the modifications hereafter mentioned, together with such local rules as in force on the course over which the competition takes place.
2. The Match Committee will settle any dispute or protest.
3. The Match Committee will make all arrangements and have full power to alter or make any variation in the conditions should they deem it desirable, and shall also have the right to refuse entry to any person without being required to give any reason for such refusal.
4. In every event competitors will be drawn against each other for the day as arranged by the Match Committee. The Match Committee shall have power to select a marker for any competitor whose fellow competitor is not at the tee when called upon at the time appointed to start.
5. Competitors must be ready at the appointed time and if not at the appropriate tee when called are liable to be sent to the end of the field. Only in special circumstances approved by the Committee, may competitors be permitted to start at a later time.
6. In the event of bad weather, the Committee may either shorten any event or reschedule to another day.
7. Ties
  - 36 Holes Scratch Event: There shall be a play-off, the time and manner of which will be determined by the Match Committee.
  - 36 Holes Nett Event: Ties will be decided by a count back on the last 18 holes, if there is still a tie then the last 9 holes will be used, then the last 6, 3 or 1 holes.
  - 18 Holes Scratch Event: Ties will be decided by a count back on the last 9, 6, 3 or 1 holes and further ties using the first nine on the last 6, 3 or 1 holes.
8. In the Handicap Event, if a competitor's handicap alters during the course of the competition her original handicap shall prevail throughout.  
Exception – 18 Hole Nett score in second round.
9. The Match Committee reserves the right to limit the number of entries by ballot.
10. The winner of the Daily Gross 18 Holes Event is not eligible to win the 18 Holes Handicap Event
11. Winners are asked to be present to receive trophies.
12. Scratchings - Players are asked to notify the club where drawn to play.
13. Slow play – Players are reminded that if they lose a clear hole on the group ahead of them they must let the following players through.

## DRESS REGULATIONS

Suitable golfing attire to be worn at all times. Competitors are required to comply with the dress regulations of the Host Club.
