## STANDARD CONDITIONS OF PLAY

### 1. THE TOURNAMENT

The tournament will be played in handicap divisions at **McLeod Golf Club** over 18 holes stroke play on **Sunday 31 March 2019**.

### 2. TOURNAMENT COMMITTEE

The BDLGA Tournament Committee shall have sole management and control of the event. The Tournament Committee reserves the right to: (a) fix and/or alter starting times; (b) in the event of bad weather, or for any other reason, either shorten the contest or fix another date/venue; (c) vary any condition should they deem it advisable; (d) reject any entry without assigning any reason therefore. The decisions of the Tournament Committee shall be final in all matters and in the absence of a full committee, such members as may be present at the time may give a decision, and any such decision shall be deemed to be a decision of the full Tournament Committee.

### 3. ENTRIES

**3.1** The Tournament is open to all female junior amateur golfers with a Golf Australia Handicap who are members of a club affiliated, through their District Golf Association with Golf Queensland, or with other State Golf Associations. A junior is a golfer who has not and will not attain the age of 18 years on or before **Sunday 31 March 2019**.

**3.2** Entries must be received by the B&DLGA **5:00pm Sunday 17<sup>th</sup> March 2019**. Late entries will be accepted at the discretion of the Committee. It is the player's responsibility to ensure that their entry is received by the B&DLGA on or before the closing date.

**3.3** The prescribed nomination fee of \$20.00 (incl. GST) **MUST** accompany the nomination form at the time of entry. Email entries will be accepted.

**3.4** Do not send cash in the mail. The B&DLGA will not accept responsibility for cash sent that is not received.

**3.5** Entries without a Golf Link number **MUST** be accompanied by a handicap record endorsed by an official of the player's home club.

**3.6** Nominations are accepted at face value, on the basis that information contained therein is correct and up to date. Should this subsequently be proven not to be the case, the B&DLGA reserves the right to deem any competitor ineligible at any time prior to or during the Junior Championship.

**3.7** Once the draw is completed there will be no refund of entry fees for players who withdraw from the

event. Players who withdraw prior to the draw being published will be refunded their entry fee.

### 4. PUBLICITY

The B&DLGA arranges publicity before, during and/or after this tournament. It is a condition of entry that all players assent to references to them and pictures of them in practice and play being published via any medium (including the internet).

### 5. PRIVACY

The B&DLGA may retain the personal details (ie: name, address, handicap) of entrants in this tournament on its records. The purpose of doing so is such that information on other future events conducted by the B&DLGA can be forwarded as deemed appropriate by the B&DLGA. This information will not be available to any other organisation.

### 6. DRESS REGULATIONS

Players must comply with the dress regulations of the Host Club.

### 7. PRACTICE

Practice rounds at the Host Club can be arranged by contacting the Pro Shop. Availability is at the discretion of the Host Club.

### 8. RULES

The Rules of Golf as adopted by the R&A Rules Limited will apply, together with the Golf Australia Hard Card and supplementary Local Rules as are approved by the Tournament Committee.

### 9. COURSE MARKERS

During practice or during the tournament a player shall not place on the course, or cause to be placed on the course, any artificial marker or other device designed to indicate course measurements. A player in breach of this condition will be disqualified.

### 10. DRAW AND STARTING TIMES

A draw for the day will be published on the B&DLGA Junior Facebook Page and B&DLGA website. Players shall start at the time and in the order arranged by the Tournament Committee. Rule 5 provides "*The player shall start at the time laid down by the Tournament Committee*". The penalty for breach of Rule 5 is disqualification. However, it is a condition of this tournament that in the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 5.3, if the player arrives at her starting point, ready to play, within five minutes of her starting time, the penalty for failure to start on time is two strokes, instead of disqualification.

### **11.CADDIES**

A player **IS PERMITTED** to use a caddie during a stipulated round. The caddie must sign a caddie form prior to the start of the round.

### **12.DRIVING CLUBS**

Any driver the player carries must have a clubhead, identified by model and loft, that is named on the current List of Conforming Driver Heads issued by the R&A.

Exception: A driver with a clubhead that was manufactured prior to 1999 is exempt from this condition. **PENALTY FOR CARRYING, BUT NOT MAKING STROKE WITH, CLUB OR CLUBS IN BREACH OF CONDITION:** Stroke Play – two strokes for each hole at which any breach occurred; maximum penalty per round – four strokes. \*Any club or clubs carried in breach of this condition must be declared out of play by the player to her marker or a fellow competitor immediately upon discovery that a breach has occurred. If the player fails to do so, she is disqualified. **\*PENALTY FOR MAKING STROKE WITH CLUB IN BREACH OF CONDITION:** Disqualification.

### **13.BALL**

The ball the player plays must be named on the current List of Conforming golf Balls issued by the R&A. **PENALTY FOR BREACH OF CONDITION:** Disqualification.

### **14.USE OF MOTORISED VEHICLES**

Players may not ride on any form of transportation during a stipulated round unless authorised by the Tournament Committee. **PENALTY FOR BREACH OF CONDITION:** Two strokes at each hole at which a breach of this condition occurred; maximum penalty per round – four strokes.

### **15.MOBILE PHONES**

The use of mobile phones by players during the play of any competition round is prohibited. Serious breaches of etiquette may result in disqualification.

### **16.PACE OF PLAY**

Rule 5-6 will be strictly enforced. A Pace of Play schedule and description of the applicable penalties for breaching this schedule will be supplied to competitors prior to the first round of the tournament.

### **17.DRUG TESTING**

All competitors are subject to drug testing by the Australian Sports Drug Agency for banned substances as laid down in the Golf Australia's Doping Policy – endorsed by Golf Queensland/Junior Golf Queensland/BDLGA. Any competitor infringing this policy or refusing to take a test may be disqualified.

### **18.SMOKING AND ALCOHOL**

Smoking and/or the consumption of alcohol by competitors and caddies on the course is not permitted. Also not permitted around juniors on and off the course.

### **19.TIES**

In the event of a tie or ties for the tournament, unless the Tournament Committee otherwise determines, the winner/s will be decided by a countback as per the Golf Australia countback system.

### **20.DISTANCE MEASURING DEVICES**

In this competition, a player may obtain distance information by use of a distance measuring device. If, during a stipulated round, a player uses a distance measuring device to gauge or measure other conditions that might affect play (eg: elevation changes, wind speed etc), the player is in breach of rule 4-3.

### **21.PROTESTS**

Protests must be lodged in writing with the Tournament Committee no later than five minutes after the conclusion of the player's round on each day.

### **22.CODE OF CONDUCT**

All entrants are bound by Golf Australia's Code of Conduct ('the Code'). A copy of the Code is available at [www.golf.org.au](http://www.golf.org.au). Any breach of the Code may be recorded on the Central Register of the Code ('the Register'). The Register may be accessed (and published from time to time) by any State Association or Golf Australia for the purposes of administering competitions or state championships, events, competitions, practice sessions or major activities conducted or sanctioned by a State Association, or any State Association or Golf Australia codes of conduct and/or other related matters.

### **23.TROPIES / PRIZES**

Trophies/Prizes will be awarded after the completion of play. **NOTE:** A player is eligible to win only one trophy/prize.
