



# 2019 Queensland Senior Mid-Week Challenge

## CONDITIONS OF PLAY

### 1. THE EVENT:

- 1.1 The event will be a round robin event between teams nominated by each of the participating golf clubs. Format of play will be 18 hole match-play home and away for 'group' matches.
- 1.2 Teams will be made up of eight (8) players 55 years of age, or older on the day of competition, who hold an GA handicap. Additionally a minimum of two members must be over 60 years of age.
- 1.3 The event will be played mid-week, unless otherwise approved by Championship Committee, by teams representing golf facilities with 9 holes or more within the State of Queensland.
- 1.4 Each team will play one home and one away contest against each other team. Flights will be introduced and determined by the QUEENSLAND Match Committee.
- 1.5 Four (4) of the matches will be individual scratch match-play, two (2) matches will be handicap fourball match-play. Each match will be held over 18 holes.
- 1.6 The event will be capped at a maximum of 12 Clubs, 15 Clubs or 18 Clubs. This will be based at time of Entry. This is for grouping purposes.
- 1.7 Clubs with two courses may nominate two teams.
- 1.8 A GA handicap maximum of 18 will apply and all handicap matches will be played using  $\frac{3}{4}$  of the difference.
- 1.9 The Captain/Manager of each team shall prepare a list of the players in numerical playing order. This list is to be submitted to the host club's match committee, no later than ten (10) minutes before the scheduled starting time. (Players 1-4 will be the scratch participants, players 5-8 the handicap fourball participants.)
- 1.10 For flight rounds, points will be allocated based on the aggregate of matches on one day (2 – win, 1-draw, 0-loss).
- 1.11 The winning team will be the one with the highest aggregate points at the conclusion of the home and away series.
- 1.12 For players to be eligible for the finals, they must have competed in a minimum of 2 of the round robin fixtures
- 1.13 All fixtures shall be played on the dates and at the times allocated with the draw, unless altered with the approval of the QUEENSLAND Match Committee.
- 1.14 In the event of a match being cancelled, it may be rescheduled to a date and time agreed to by both clubs, preferably in the same week, but must be prior to the last day of the normal "home and away" season. This date must be confirmed with Queensland. In the event the match cannot be rescheduled, a draw will be awarded.
- 1.15 **Finals**  
The winning team from each group will then compete in home and away knockout matches until two play-off in the State Final.  
The team accumulating the most points in each division at the conclusion of the qualifying rounds will advance to the Final Series In the case of a tie the count-back, as listed in 1.16, will be used to determine the winner of each division and the same count-back system will be used to establish the order of these teams.  
Additionally, when there is an uneven number of divisions, the team with the next best record in all divisions will qualify for the finals in the #4 position and will play the # 1 team, as determined, in one

semi-final and the #2 & #3 teams will play in the other semi-final.

- 1.16 Where a count-back is necessary to determine a winner, the criteria will be:
  1. Total all matches for - against percentage
  2. Removing any squared matches, then for - against percentage
  3. Aggregate holes won and lost with a forfeit equivalent to a 3 hole loss.

*Please note- Point(s) 1.13 and 1.15 will be confirmed once entries have closed and the total number of clubs/teams for the 2019 event has been confirmed.*

### 2. CHAMPIONSHIP COMMITTEE:

- 2.1 A Championship Committee appointed by Queensland shall have sole management and control of the event. The Championship Committee reserves the right to (a) vary any condition should they deem it advisable, (d) reject any entry without assigning any reason therefore. The decisions of the Championship Committee will be final in all matters and in the absence of a full committee, such members as may be present at the time may give a decision, and any such decision shall be deemed to be a decision of the full Championship Committee.
- 2.2 QUEENSLAND will nominate the Match Committee for the day, which will be the Host Club Match Committee plus a representative from the visiting club.
- 2.3 All players, caddies and club officials must agree to abide by the Conditions of Play for this event, the Code of Conduct documents of Queensland and all decisions of the QUEENSLAND Match Committee
- 2.4 For matters of dispute the QUEENSLAND Match Committee decision shall be final

### 3. ENTRIES:

- 3.1 The 2019 Queensland Senior Mid-Week Challenge is open to all affiliated Queensland Golf Clubs.
- 3.2 Entries must be received by Queensland Office by 5pm on the Friday 22<sup>nd</sup> March. Late entries will be not be accepted.
- 3.3 The prescribed Nomination Fee of \$70.00 per team (incl. GST) must accompany the nomination form at the time of nomination. Please send your entry to [info@golf.org.au](mailto:info@golf.org.au)
- 3.4 Do not send cash in the mail - QUEENSLAND will not accept responsibility for cash sent that is not received.
- 3.5 Nominations are accepted at face value, on the basis that information contained therein is correct, and up to date. Should this subsequently be proven not to be the case, QUEENSLAND reserves the right to deem any competitor ineligible – at any time prior to or during the Championship.
- 3.6 Once the draw is completed there will be no refund of entry fees for teams who withdraw from the event.

### 4. ELIGIBILITY

- 4.1 Teams will be made up of eight (8) male amateur

players 55 years of age or older on the day of competition, who hold an Australian Men's handicap. Additionally a minimum of two members must be over 60 years of age.

- 4.2** Players competing must be a member of the club they represent. Individual clubs determine which membership categories are eligible for selection in this event.
- 4.3** Players, who are country, interstate or absentee members are not eligible.
- 4.4** Players may represent **only one QUEENSLAND** affiliated club team in any one calendar year when competing in the competition.

- 5. PUBLICITY:** QUEENSLAND arranges publicity before, during and/or after this Championship. It is a condition of entry that all players assent to references to them, and pictures of them in practice and play being published via any medium (including the internet).
- 6. PRIVACY:** QUEENSLAND may retain the personal details (i.e. name, address, handicap) of entrants in this Championship on its records. The purpose of doing so is such that information on other future events conducted by QUEENSLAND (or other parties) can be forwarded as deemed appropriate by QUEENSLAND. This information will not be available to any other organisation. Any person may have their details removed from this database by phoning QUEENSLAND on 3252 8155.
- 7. DRESS REGULATIONS:** Players and Caddies must comply with the dress regulations of the host golf club.
- 8. PRACTICE:** Practice will be on the terms and conditions as determined by each host club.
- 9. RULES:** The Rules of Golf as adopted by the R&A Rules Limited will apply together with such Local Rules at each host club.
- 10. ADVICE:** The team captain is permitted to give advice during play of each match.
- 11. COURSE MARKERS:** During practice or during the Championship a player shall not place on the course, or cause to be placed on the course, any artificial marker or other device designed to indicate course measurements. A player in breach of this condition shall be disqualified.
- 12. DISTANCE MEASURING DEVICES:** For all play in this Championship a player may obtain distance information by use of distance-measuring device. If, during a stipulated round, a player uses a distance-measuring device to gauge or measure other conditions that might affect his play (eg, elevation changes, wind speed, etc), the player is in breach of Rule 14-3.
- 13. DRAW:** Following the close of entries a "draft" draw will be issued by QUEENSLAND to each club. Each host club will then be asked to provide a day and time for the match within the week allocated for the match. Upon receipt of these dates and time the QUEENSLAND will publish the final draw on its website [www.golfqueensland.org.au](http://www.golfqueensland.org.au) as well as email each of the nominated club contacts. A draw for each round of the season will be published by early April. It is anticipated that the first round matches will be held in the last week of April.
- 14. STARTING TIMES:** Players shall start at the time and in the order arranged by the Committee. Rule 6-3a provides "The player shall start at the time laid down by the Committee." The penalty for breach of Rule 6-3a is disqualification. However it is a condition of this Championship that, in the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7, if the player arrives at his starting point, ready to play, within five minutes of his starting time, the penalty for failure to start on time is loss of hole, instead of disqualification.
- 15. CADDIES:** Caddies are permitted during this event.
- 16. BALL:** It will be obligatory for all competitors in the Championship to play with a ball which is named in the current

R&A and/or USGA Approved Lists. Copies of these lists are available from [www.randa.org](http://www.randa.org). Penalty: Disqualification.

- 17. USE OF MOTORISED VEHICLES:** The use of motorised carts is permitted in this event and may be deemed compulsory by the host club.
- 18. MOBILE PHONES:** The use of mobile phones by players and/or caddies during the play for other than medical emergencies is prohibited. Serious breaches of etiquette may result in disqualification.
- 19. RESULTS:** On the completion the match, the host club is to communicate the agreed result to QUEENSLAND-[info@golf.org.au](mailto:info@golf.org.au)
- 20. CODE OF CONDUCT:** All entrants are bound by Golf Australia's Code of Conduct ("the Code"). A copy of the Code is available at [www.golfaustralia.org.au](http://www.golfaustralia.org.au). Any breach of the Code may be recorded on the Central Register of the Code ("the Register"). The Register may be accessed (and published from time to time) by any State Association or Golf Australia for the purposes of administering Competitions or state championships, events, competitions, practice sessions or major activities conducted or sanctioned by a State Association, or any State Association or Golf Australia codes of conduct and/or other related matters.
- 21. PROTESTS:** Protests must be lodged in writing with the Match Committee no later than 5 minutes after the conclusion of the player's round on each day. For matters of dispute the QUEENSLAND Match Committee decision shall be final.
- 22. TROPHIES:** A trophy will be awarded to the winning club in the State.

- To provide match committee point of reference for the day.
- On the completion of the match, communicate the agreed result to Queensland.
