CONDITIONS

A qualifying foursomes event is held within the club's calendar.

Competitors may participate in multiple qualifying rounds of the Barclay Shield (multiple clubs). However competitors may only represent one club in the State final. If one were to qualify at two clubs, a competitor would only be eligible to compete for the club where the individual's handicap is held and maintained.

Entry fee \$3.30 per player for each player who enters, not just the pairs that play in the finals (i.e. 55 competitors @ \$3.30 = \$181.50).

Pairs with the best two nett scores are eligible to represent their club in a final event, at a course to be nominated by Golf Australia-Tasmania.

The winning club is the one with the best nett aggregate score on this day, and holds the Barclay Shield for one year.

Clubs must return the completed entry form to the General Manager after club fixtures have been finalised and prior to Friday 16 August, 2019.

Should the qualifying pair(s) be unable to play in the final they MUST be replaced by the next best qualifying scores. Only pairs that played in the qualifying event are eligible for the State final.

If a club is not otherwise able to field the next best qualifying pair(s) due to unforeseen circumstances, composite pairs may be entered at the discretion of the Golf Australia-Tasmania Tournament, Rules and Ratings Committee.

Permission must be sought in writing from the Golf Australia-Tasmania Tournament, Rules and Ratings Committee.

In the event of a tie the results will be decided by count-back, the count-back to be decided on aggregate of the last nine holes.
