



2020 ISPS Handa Vic Open - Event Waiver

Golf Australia is committed to providing a safe working environment for all staff and volunteers.

Volunteers primarily should look out for the health and safety of themselves and that of fellow co-workers, volunteers and the public. Prior to the commencement of each shift at the event, all volunteers must report to and register at Volunteers HQ.

All volunteers are required to familiarise themselves with the security arrangements, emergency procedures and safe work instructions for their area and role. These include, but are not limited to:

Security:

Security at the 2020 ISPS Handa Vic Open is paramount for all staff, visitors, players, officials, spectators and medical staff. Security is provided in numerous ways including accreditation checks, ticketing, sign-in procedures and evacuation and emergency procedures.

Emergency Procedures:

There is an established Emergency Management Procedure for this event and venue. All volunteers are required to make themselves familiar with the following:

- Location of first aid resources
- Location of emergency exits
- Emergency response procedures

Health & Safety:

Health and safety procedures are a high priority at the 2019 Vic Open. All volunteers and staff need to be aware of safety issues in their area. Site safety instructions include but are not limited to:

- Co-operate with all volunteers and staff on health and safety matters
- Familiarise yourself with any emergency arrangement for the activities you are carrying out
- Be aware of specific safety issues in your area
- Take care when lifting or carrying heavy items, always seek assistance for heavy or awkward items
- Only use equipment, machinery and vehicles if you are authorised and trained to do so
- Wear protective clothing (PPE) where required
- Slip, Slop, Slap wear sunscreen, hats and stay hydrated
- Report all hazards or incidents to a staff member or directly to your supervisor
- Remove yourself from and warn others of imminent danger
- If you don't feel safe, seek assistance immediately.

Incident Reporting:

Incident Report Cards are to be used for reporting operational issues or to make suggestions. Incident details are required if you encounter lost property, theft, property damage, a safety hazard, a medical condition or injury.

- An incident report card will be available at Volunteer HQ
- Contact your supervisor in the case of a serious issue or incident
- Complete an Incident Report Card as soon as possible and hand in at the Volunteer HQ





Responsible Behaviour & Code of Conduct:

As a volunteer for Golf Australia certain conducts of behaviours are expected to be adhered to whilst undertaking volunteer duties:

- No volunteer should be under the influence of illegal drugs or alcohol when volunteering.
- Volunteers must behave in a responsible and reliable manner.
- Volunteers are acting as representatives of Golf Australia and should adhere to the highest standards of honesty, integrity and where appropriate confidentiality.
- Volunteers should not make any public comments or statements to the media that would lead anyone
 to believe you are representing the views of Golf Australia, all media appearances should be
 accompanied by your Supervisor or the Volunteer Coordinator.
- If medication is required, volunteers should ensure to have this with them at all times, all staff and volunteers will have access to a basic first aid kit.
- All volunteers are expected to disclose any conflicts of interest which may arise and could have an impact on your obligations to Golf Australia.
- If resigning from your volunteer role, it would be appreciated if you could give adequate notice. We are committed to constantly improving the event and this will allow us to replace your role promptly.

Dealing with the Media:
