Formats: Category 1 – 6 holes of Stableford Competition with Finals Shootout

Open to girls, under 18 years of age (as on the day) who hold a current GA

handicap of 16.2 or above. The field is limited to 40 entrants

Category 2 – 6 holes of modified Stroke Ambrose Competition

Open to girls, 10-17 years of age (as on the day) who do not hold an official

handicap. The field is limited to 20 entrants

Prizes: Category 1 – Top qualifier, all finalists and Winner of the shoot-out

Category 2 – Winning team & individual prizes NTP's, Longest Drives, Straightest Drives.

The Victorian Girls Six Hole Challenge is designed to promote the game to girls and provide intermediate and novice golfers the opportunity to play a golf event in a fun and relaxed environment at a premier course located in the renowned Melbourne Sandbelt.



# Victorian Girls' Six Hole Challenge

#### 1. COMPETITION PROCEDURES

- 1.1 The category 1 event is scheduled to be played over 6-holes stableford with finals shootout. The category 2 event scheduled to be played over 6-holes modified stroke Ambrose.
- **1.2** Following the 6-holes stableford qualifying, the leading 4 players plus ties will qualify for the finals shootout in Category 1.
- Entries will be accepted on an as received basis until the field capacity is reached. The field for category 1 is restricted to the first 40 entrants, and the field for category 2 is limited to the first 20 entrants.
- **1.4** No caddies please. (See 5 below)

### 2. CATEGORY 1 ELIGIBILITY

2.1 Eligible players are female amateurs who are aged under 18-years old as at the day of the competition and whose GA Handicap on the day of the event is over 16.2.

#### 2.2 CATEGORY 2 ELIGIBILITY

Eligible players are female amateurs who are aged 10-17 years old as at the day of the competition and do not hold a GA Handicap.

#### 3. ENTRIES

- **3.1** Entry fee must be paid at the time of entry.
- 3.2 The Tournament Committee shall have the right to refuse the entry of any person without being required to give any reason for such refusal.
- **3.3** Entries shall only be made online at <a href="https://www.golfvic.org.au">www.golfvic.org.au</a>.
- 3.4 Entries close 5:00pm on Wednesday 10 January, earlier if field capacity is reached.

### 4. TROPHIES

- 4.1 CATEGORY 1 The player who wins the final shootout will be the winner named on the perpetual trophy and shall receive a prize. All other finalists shall also receive a prize.
- **4.3 CATEGORY 2** The team with the lowest stroke score shall receive prizes.
- **4.3** Prizes for NTP's, Longest drives, Straightest Drives.
- In case of a tie the Golf Australia count back method will be used to separate all trophies in Category 2. A shootout will be used to separate any ties in Category 1.
- 5. Woodlands Golf Club will appoint a qualified adult to walk with each group to assist with scoring, Rules & pace of play. Hence caddies are not allowed.

The Tournament Committee shall consist of representatives of the Woodlands Golf Club. In the absence of the full Tournament Committee, present members of the committee at any time may give a decision and any decision shall be deemed the decision of the full Tournament Committee. The Tournament Committee reserves the right to vary any condition of this event. In the event of bad weather, or for any other reason, the Tournament Committee may shorten the competition, appoint another day or days for completion of, or may transfer play to another course. The decision of the Tournament Committee will be final in all matters relating to the Tournament.

#### 7. PRIVACY
