### VENUE ALLOCATIONS, DRAW & REGISTRATION

Women will be allocated to Sanctuary Lakes, with Men split across Curlewis & Ranfurly.

Venue allocations will be published at [www.vicopengolf.com/entries](http://www.vicopengolf.com/entries) on Friday 24 January. The draw will be published on the same link by 5.00 pm on Friday 31 January.

Tee times at all venues will be from 7.30 am to 9.30 am (approx) from the 1<sup>st</sup> and 10<sup>th</sup> tees with registration to commence at 6.30 am.

### MAXIMUM NUMBERS & WAITING LIST

Maximum numbers at each venue will be 100. A waiting list will be available for both men & women with players balloted in accordance with Tournament Condition C4 as follows:

- PGATA/ET/ALPG/LPGA Full Tournament Members
- Full Members of the Australian PGA (based on most recent Final National Rankings, then order of entry)
- PGATA Affiliate Members
- PGA of Australia Senior Tournament Members
- Members of other recognised Tours (in order of date of entry)
- Members of other recognised PGAs (in order of date of entry)
- Non-aligned professionals (in order of date of entry)
- Amateurs in exact handicap order (handicap as at close of entry).

### QUALIFICATION FOR CHAMPIONSHIP PROPER

Two (2) women's and four (4) men's places will be available in the Championship Proper for non-exempt players.

Ties for the last available place will be decided by sudden-death, hole-by-hole play-off as soon as practicable after all players have finished play.

Reserve places (alternates) in case of subsequent withdrawals of Qualifiers from the Championship Proper will be decided by sudden-death, hole-by-hole play-off.

## ALTERNATE POLICIES

### Men:

Alternates generated from the pre-qualifying tournament will remain as Alternates only for those players who become eligible for the tournament field through the pre-qualifying tournament.

Any position in the tournament field that becomes available through a withdrawal of an exempt player after registration closes at 2.00pm AEDT on Wednesday 5 February, will be filled from the ranked Category Members of their respective Tour. If the European Tour has no further players available to fill a position, that position will revert to the PGA Tour of Australasia as it does normally.

For sake of clarity, during Round 1, if a player fails to arrive at the tee within 5 minutes after their tee time, their position will be filled by the first alternate from their Tour if available. If no eligible tour Member is available then the next available alternate from pre-qualifying can take that place.

### Women:

In the event of an exempt player withdrawing from the Championship or further places becoming available in the starting field up until the commencement of Qualifying (i.e. 8.00 am AEDT on Monday 3 February), these places will be taken from the relevant LPGA and ALPG eligibility categories. In the event players are not available from the relevant eligibility categories, remaining places will be filled by the alternates from the qualifying. Places in the field as a result of withdrawals after 8.00 am on Monday 3 February will be allocated to the alternates from Qualifying.

## PULL BUGGIES

Limited number of pull buggies are available at each venue. Competitors are encouraged to bring their own.

## RESULTS

Scores will be posted for each player immediately following scorecard verification and will be available at [www.vicopengolf.com/entries](http://www.vicopengolf.com/entries). Successful qualifiers along with alternates will be indicated on the leaderboards following the conclusion of play.

Any competitor who does not show for qualifying, and who does not advise of their withdrawal, will be listed as Disqualified for result purposes.

## CHAMPIONSHIP PROPER AND REGISTRATION

The Championship Proper will be played at 13th Beach Golf Links in Barwon Heads from 6-9 February 2020. Successful qualifying competitors must register at the Player Services office at 13<sup>th</sup> Beach between the following hours:

- **Monday 3 February:** 9.00am – 5:00pm
- **Tuesday 4 February:** 7.00am – 5.00pm
- **Wednesday 5 February:** 7.00am – 2.00pm

## G-2 GROOVE AND PUNCH MARK SPECIFICATIONS

The following regulation applies to the **Championship Proper AND QUALIFYING**:

In making a stroke, the players must use clubs that conform to the groove and punch mark specifications in the *Equipment Rules* that took effect on 1 January 2010.

An Equipment Database of fairway woods, hybrids, irons and wedges which have been tested for conformance to the current *Equipment Rules* is found at [RandA.org](http://RandA.org).

### Penalty For Making a Stroke with Club in Breach of this Local Rules: Disqualification

There is no penalty under this Local Rule for carrying but not making a *stroke* with a club which does not conform to these groove and punch mark specifications.

## DISTANCE AND DIRECTIONAL INFORMATION

As per Rule 4.3a(1), a player may obtain information on distance or direction (such as from a distance-measuring device or compass). **Please note DMD's are NOT permitted in the Championship proper.**

## DRESS CODE – FINAL QUALIFYING

During both practice and competition, competitors and their caddies must ensure a standard of dress in keeping with the host club dress regulations. *Note: shorts are permitted for both male & female competitors.*

## COURSE CARE / CLUB REGULATIONS & GA CODE OF CONDUCT

Players are reminded that sand buckets **MUST** be taken and used, pitch marks are to be repaired, and bunkers raked following play at each course. Players seen to be in breach of this request may face action under Golf Australia's [Code of Conduct](#). Mobile phones are not to be used in the clubhouse and are permitted during a stipulated round to access a distance measuring device application or to call for a ruling only.

## PRACTICE POLICY

Practice putting and chipping on the green of the hole last played is prohibited in Qualifying and the Championship Proper.
