# TERMS OF COMPETITION

## 1. COMPETITION PROCEDURES

- 1.1 The 2023 Royal Women's Hospital 4BBB is to be played at club level only.
- 1.2 Eligible clubs are Golf Australia Victorian affiliated clubs. It is played separately or in conjunction with an existing club 4BBB Stableford event.
- 1.3 The event is to be played by **Monday 30 October 2023**.
- 1.4 Clubs are to submit their club winners and total funds raised to Golf Australia via GolfBox by **Wednesday 1 November 2023**.
- 1.5 The pair who records the highest Stableford score in the club round from all participating clubs shall be the 2023 RWH 4BBB Winner. Other prizes will be awarded as per condition 4. Note: scores do not need to be converted as the World Handicap System caters for differing course difficulties.
- 1.6 In the event of a tie to determine any prize, a count-back according to the Golf Australia count-back method will be used to determine the winner and/or runner-up.
- 1.7 Clubs may be required to submit the winning score card to GA in the case of a count-back.

## 2. ELIGIBILITY

- 2.1 Eligible players are female amateurs who hold a GA Handicap. Players must be a financial member of the club they are representing.
- 2.2 Players must be a member of the Golf Australia Victorian affiliated club they where they contest the club round.

## 3. ENTRIES

- 3.1 The entry fee is \$12.00 per pair (incl. GST) to be paid by players at the club round. Clubs are to enter their winning pair and submit all entry fees to GA by 1 November 2023.
- 3.2 GA has the right to refuse the entry of any person without being required to give any reason for such refusal.
- 3.3 Entries shall only be made via the online tournament system, GolfBox.
- 3.4 It is the sole responsibility of the club to ensure that entries are received prior to the closing date.

## 4. TROPHIES

Prizes will be awarded to the following based on scores from club rounds:

- Overall winning pair
- Overall runner up pair
- Regional winning pair
- Metropolitan winning pair

Note i: VGL clubs are classified as Metropolitan clubs.

Note ii: Pairs are entitled to win one prize only with the overall winning and runner up pair taking precedence.

Note iii: Each club is permitted to win a maximum of one prize.

## 5. CHAMPIONSHIP COMMITTEE

The Committee shall consist of Golf Australia representatives. In the absence of a full Championship Committee, such members thereof, as may be present at the time, may give a decision so given shall be deemed to be a decision of the full Championship Committee.

## 6. MOTORISED TRANSPORT

Competitors are permitted to ride in or on a motorised vehicle during any round of the competition (subject to availability). It should be noted that the hire or provision of such transport is at the competitor's own expense subject to arrangements and agreements with each host club.

## 7. RULES OF GOLF

The Rules of Golf, as adopted by R&A Rules Limited, and any supplementary local rules as determined by the Championship Play Committee, will apply.

## 9. DATABASE OF COMPETITORS' DETAILS

The personal data contained in this entry is permanently retained by GA. This data may be utilised by GA or its sponsors for the distribution of correspondence, in both electronic and hard copy means. From time to time players may be sent entry forms, event literature, the GA e-newsletter, or marketing material by the sponsor(s) of GA events, or information about events conducted by GA approved bodies. Upon receipt by GA of a written request, a player may either have access to their details, or have their details deleted from the database.
