# TERMS OF COMPETITION

#### COMPETITION PROCEDURES 1.

- 1.1 Competition Structure
- **1.1.1** The championship will be played in three sections:
- Men's section
- Women's section
- Mixed section
- 1.1.2 The championship will be played in two rounds
- Qualifying rounds
- Championship Final

# **Qualifying rounds**

- 1.2.1 All entering pairs must compete in a qualifying round at their chosen qualifying venue. Each venue shall arrange one qualifying round on dates decided by the club, between 1 August 2024 and 31 January 2025. Qualifying rounds shall consist of 18 holes of Four-ball stableford play. Each entering pair may compete in multiple qualifying rounds.
- 1.2.2 Each individual player is permitted to enter as part of a men's or women's or mixed pair (if applicable).
- 1.2.3 A minimum of 6 pairs will qualify for the state final, consisting of the leading two men's, women's and mixed pairs (if applicable) from each qualifying venue with remaining places filled by the next best score. Please note: qualifying numbers are subject to change depending on final numbers.
- 1.2.4 Players who have already qualified for the state final may compete at further events for prizes but cannot qualify again or with a different partner. Exception: Before playing a second qualifying round, a player can notify Golf Australia that the pair who previously qualified cannot participate in the state
- 1.2.5 Ties for the last places of qualifying pair(s) in any section and all trophies will be decided by the system of countback as specified by Golf Australia.
- 1.2.6 Substitutions- Subject to the approval of the Championship Committee, following entry into the competition, it is permissible to substitute an alternative player for a nominated player who is unable to compete due to illness, injury or any other justifiable reason. However, only one player substitution can occur at the specific qualifying round or State Final. If both players are unavailable to play, they must withdraw allowing any subsequent pairs on the waiting list to participate. The substitute player must be eligible to compete in accordance with the conditions of the competition.

#### 1.3 **Championship Final**

- 1.3.1 The Victorian Four-Ball Championship State Final shall consist of 36 holes of Four-Ball stableford play. Venues and dates will be announced.
- 1.3.2 The field for the Championship Final will consist of pairs who qualify via a qualifying round, as per term 1.2.3 above.
- **1.3.3** In the event of a tie for the championship and all trophies in any section, all positions/winners shall be decided by the system of count-back specified by Golf Australia.

# **ELIGIBILITY**

- 2.1 Eligible players are male and female amateur golfers whose Golf Australia handicap (or overseas equivalent) at the time of entry does not exceed 36.4 strokes (men) and 45.4 strokes (women).
- In accordance with Section 17 of the GA Handicap System, the Championship Play Committee reserves the right to allocate Special Competition Handicaps to any player participating in the Victorian Four-Ball Championship. Circumstances which may lead to such action includes (but is not limited to):
  - Qualification for a minimum of two State Finals over the past four years:
  - Finished with a two-round total of 86 points of more at the previous year's State Final;
  - Qualification for the current year's State Final with a score that in the view of the GA Match committee has not resulted in an appropriate reduction of one or both player's GA Handicaps following application of the GA Handicap system;

Achieved notable performances in club, district, or other external four-ball and/or team competitions

Note: Such Special Competition Handicaps may apply solely to the Victorian Four-Ball Championship or to all four ball/teams' events (including club/ district events) for a defined period as determined by

2.3 Players must comply with GA's Gender policy at the time of the competition.

#### **ENTRIES** 3.

- 3.1 All entries shall only be made online via the registration link at www.golf.org.au/vicfourball. Or via the qualifying host club.
- GA shall have the right to refuse the entry of any person without being required to give any reason for such refusal.
- 3.3 The draws for the competition will be sent to players via clubs and available at www.golf.org.au/vicfourball approximately one week prior to the event.

# **Qualifying Venues**

Entry price and maximum field size at each qualifying venue shall be determined by each club and entries will be accepted on an as received basis

### **State Final**

Entries for the State Final will consist of pairs as per term 1.2.3 above with an entry fee of \$300.00 per pair. Entry fee includes green fees, trophies and lunch each day of the final.

# STATE FINAL TROPHIES

# State Final (36-Hole Stableford)

- Winning Pair Men's, Women's & Mixed Sections
- Runner-Up Pair Men's, Women's & Mixed Sections
- Best 18-Hole Stableford (Rd 1 & 2) Men's, Women's & Mixed
- Daily NTP Men & Women
- A pair cannot win more than one daily prize each day (excl NTP), with 36-Hole prizes taking precedent over 18-Hole prizes. Trophies subject to change depending on final numbers.

# CHAMPIONSHIP PLAY COMMITTEE

- 5.1 The Championship Play Committee will comprise of Golf Australia representatives and a club representative of the host club.
- In the absence of a full Championship Play Committee, such members as may be present at the time may give a decision, and any decision so given will be deemed to be a decision of the full Championship Play Committee.
- The Championship Play Committee will have the sole management and control of the Championship, with full power at any time to alter or vary any of the terms
- **5.4**. The Championship Play Committee's decision on matters affecting the Championship will be final.

# **REFUND POLICY**

Any entrant may withdraw and have the entrance fee refunded provided notification is received 5 days prior to the first round. To be eligible for a refund after this time players must provide GA supporting documents regarding their withdrawal from the event (eg. medical certificate). In the case of an event not being completed (for example due to weather delays) refunds will not be provided.

#### MOTORISED TRANSPORT 7.

#### 7.1 **Qualifying Rounds**

- 7.1.1 The Rules of Golf apply which means there are no restrictions on the use of motorised transport; at the discretion of the host club.
- 7.1.2 Golf carts are at the player's own expense and MUST be booked directly with the host club. Carts are subject to availability, and players may be requested to share.

#### State Final 7.2

A player or a caddie will only be permitted to ride on motorized transportation in circumstances expressly described in (a) or (b) or (c) below.

- When authorised (or later approved) by the committee that arise during the playing of a round. For example, a player who is about to play (or who has just played) under penalty of stroke and distance, and their caddie, is automatically authorised to ride on motorised transportation.
- When approved by Golf Australia as a person who currently required the use of motorised transportation in order to participate in the game of golf. To be considered for approval, the player or caddie must provide to Golf Australia written advice from a medical practitioner, or a physiotherapist, or a chiropractor, or an osteopath, or the like, stating they currently require the use of motoriesd transportation to participate in the game of golf. The advice must be emailed to <u>liam.green@golf.com.au</u> before the event's closing time for entries. The advice from the health professional must specify the period of time that use of the motorised transportation is required (i.e 1 week, 1 month, 1 year, or indefinitely). When an exemption is granted, the use of motorised transportation must solely serve the purpose of transportation.
- Any player of caddie aged 75 years or over is permitted to use motorised transportation without needing to apply to Golf Australia for approval.

Penalty for breach of Local Rule: The player gets the general penalty for each hole during which there is a breach of this Local Rule. If the breach occurs between the play of two holes, it applies to the next hole.

# **RULES OF GOLF**

The Rules of Golf, as adopted by R&A Rules Limited, and any supplementary local rules as determined by the Championship Play Committee, will apply.

# **CLUBS AND BALLS**

List of Conforming Driver Heads: Model Local Rule G-1 is in effect. Penalty for making a stroke with a club in breach of Local Rule: Disqualification.

List of Conforming Golf Balls: Model Local Rule G-3 is in effect. Penalty for breach of the Local Rule: Disqualification.

# PRACTICE (RULE 5.2)

In stroke play, Rule 5.2b is modified in this way: A player must not practise on the competition course before or between rounds. Exception: All recognised practice areas within the bounds of the course may be used by players for practice on any day of the competition.

# PACE OF PLAY (RULE 5.6)

In the absence of mitigating circumstances, a group is liable to be timed if it is in excess of the time allowed and in the case of second or subsequent groups, out of position. From the commencement of timing, if any player exceeds 50 seconds on a 'first to play approach shot (including Par 3 tee shot), chip or putt', or 40 seconds if it is a tee shot or 'second or third to play shot', they shall be deemed to have had a bad time.

The time allowed will be determined by the Committee and will be available prior to play. Out of position is defined as being more than the starting interval behind the group in front.

A player whose group is timed will have a bad time carried forward in the round even if the group subsequently arrives back in position or within time. PENALTY FOR BREACH OF LOCAL RULE:

1 Bad Time Verbal warning from referee and told that if they have a further bad time, they will be penalised;

# Stroke Play

2 Bad Times: One Stroke Penalty

3 Bad Times: Additional Two Penalty Strokes

4 Bad Times: Disqualification

### Note:

- It is not necessary for players to be advised they are being timed.
- Timings will be taken from the moment it is deemed by the Official that it is the player's turn to play.
- In exceptional circumstances, an individual player, or two of the three players in a group, may be timed.

### When Timing Commences:

Other than on the putting green, the timing of a player's stroke will begin when it is their turn to play and they can play without interference or distraction. Reasonable time spent by the first player to play in determining their yardage will not count as time taken for the next stroke.

On the putting green, the timing of a player's stroke will begin after a player has been allowed a reasonable amount of time to mark, lift, clean and replace their ball, repair damage to the green, and remove loose impediments on their line. Time spent looking at the line from beyond the hole and/or behind the ball will count as part of the time taken for the next

#### **DISTANCE MEASURING DEVICES** 12.

In accordance with Rule of Golf 4.3a(1), a player may obtain distance and direction information by use of a distance-measuring device. The provisions of Rule 4.3 apply in relation to Use of Equipment.

# **SUSPENSION OF PLAY (RULE 5.7)**

The following signals will be used to suspend and resume play:

- Immediate stop for imminent danger one prolonged note of a siren
- Stop for a non-dangerous situation three consecutive notes of a siren
- Resumption of play two consecutive notes of a siren
- Note: When play is stopped for imminent danger, all practice areas will be immediately closed.

# RETURNING OF SCORE CARD

A player's scorecard is officially returned to the Committee when the player has left the recording office/area with both feet.

# **RESULTS OF THE COMPETITION – COMPETITION CLOSED**

When the Championship trophy is presented to the winner, the results of the competition are officially announced, and the competition is closed.

# 16. ANTI-DOPING AND IMPROPER USE OF DRUGS AND MEDICINE POLICY AND OTHER SPORT INTEGRITY AUSTRALIA POLICIES

The Improper Use of Drugs and Medicine Policy within Sport Integrity Australia's National Integrity Framework and Sport Integrity Australia's National Anti-Doping Policy apply for this event. # 77. DATABASE OF COMPETITORS' DETAILS

The personal data contained in this entry is permanently retained by GA. This data may be utilised by GA or its sponsors for the distribution of correspondence, in both electronic and hard copy means. From time to time players may be sent entry forms, event literature, the GA e-newsletter, or marketing material by the sponsor(s) of GA events, or information about events conducted by GA approved bodies. Upon receipt by GA of a written request, a player may either have access to their details, or have their details deleted from the database.

# 18. CODE OF CONDUCT

All entrants are bound by GA's Code of Conduct ("the Code"). A copy of the Code is available by <u>clicking here</u>. Any breach of the Code may be recorded on the Central Register of the Code ("the Register"). The Register may be accessed (and published from time to time) by any State Association or GA for the purposes of administering Competitions or state championships, events, competitions, practice sessions or major activities conducted or sanctioned by a State Association, or any State Association or GA codes of conduct and/or other related matters.

# 19. LEGAL POLICIES (E.G. MATCH FIXING POLICY)

All entrants are bound to comply with all of GA's legal policies (i.e. <u>Match Fixing</u>) and the <u>Competition Manipulation and Sports Wagering Policy</u> within Sport Integrity Australia National Integrity Framework. These policies relate to the golfer's behaviour and the behaviour of their associates during the tournament. Any breach of these policies may result in the competitor being withdrawn from the competition and subject to investigation and disciplinary proceedings. It is the duty of the competitors and their associates to familiarise themselves with the relevant policies and ensure they comply.

# 20. SMOKING & CONSUMPTION OF ALCOHOL POLICY

Players and caddies are prohibited from smoking and consuming alcohol during a round. (Note: In addition to the more traditional forms of smoking, this policy is also considered to cover vaping and the like).

The following penalty structure applies for a breach of the above policy:

o First breach: Warning

o Second breach: One-Stroke Penalty
o Third breach: General Penalty

o Fourth breach or any

subsequent misconduct: Disqualification

The Championship Play Committee will impose any penalty, where applicable. Their decision is final.

#### 21. IMAGES

GA may arrange for promotion of the Championship, for radio, internet and television broadcasting and other exhibition and publication of the Championship or excerpts thereof in any and all media throughout the world, whether now known or hereafter developed for an indefinite period of time. By this application, the player (or their parent or guardian if they are under 18 years) consents to the use by GA, or persons authorised by GA, of their name, likeness, voice and references to them and photographs and other images of them and their play connected with their appearance in the Championship, or any portion(s) thereof, in connection with such media promotion, broadcasting and other exhibition and publication of the Championship. GA may utilise the rights granted it hereunder in connection with the promotion of this Championship as well as other GA Championships and GA. The cooperation of players with authorised representatives of the media is required, provided that no pre-Championship activities outside of those activities which are part of the Championship will be required and provided that the player's Championship play is not unreasonably interfered with.
